Report

Background

- 1. Roadworks are a source of frustration and inconvenience to road users but they are an essential operation and need to be managed carefully to minimise their impact on the travelling public.
- 2. There are 2 main originators of roadworks; The Highway Authority and public utility companies. Norfolk County Council has a responsibility to improve and maintain the highway, while the public utility companies have a responsibility to provide and maintain their infrastructure, the vast majority of which is located under the highway. From time to time developers are also required to work in the highway, carrying out improvements to facilitate access to their developments.
- 3. The table attached as appendix 1 sets out the current works that are have been completed since your last meeting, are currently in progress or are planned for the future on the A, B and C class roads within the city. More detailed roadworks information is provided online via the electronic local government information network at http://norfolk.elgin.gov.uk
- 4. The more significant schemes are highlighted below.

Winter damage resurfacing schemes

5. Since the beginning of June several roads in the city have been resurfaced using the additional winter damage money that the government allocated for roads that had been severely affected by the freezing temperatures last winter. This was in addition to the planned resurfacing works. Given the number of schemes and the fact that the funding had to be spent by the end of September co-ordinating these works to minimise disruption has been challenging but on the whole it has worked well. The winter damage work has meant that other resurfacing schemes planned for the summer have had to be rescheduled.

Finklegate

6. At the end of December 2010 Finklegate was closed to vehicular traffic when the road and some adjoining properties showed signs of subsidence. Council engineers are working with engineers of the insurance companies for the buildings to establish the cause of the subsidence and the future of the buildings. It is expected that these investigations will be concluded shortly and works can then begin to reopen the road. A verbal update will be given at the meeting.

Christmas Embargo

7. Every year both the highway authority and utility companies are banned from undertaking any planned works on the main road network, or on the majority of streets within the inner ring road, between Remembrance Sunday and the second week of January, the main Christmas shopping / sales period. The

exception to this are emergency works that cannot be delayed, and works that have no affect on the free flow of vehicles or pedestrians.

Utility works

8. At the current time there are no known planned utility works on the main road network that will cause disruption. Amey are completing the final phase of their street light replacement programme but this should have minimal impact on road users.
