Management works and recent events

- Since the last meeting of the Mousehold Conservators on 30 March 2012, volunteers have achieved at least 430 work hours at Mousehold Heath. The volunteers involved were from BTCV, the Community Green Gym, the Mousehold Heath Defenders, Skilforce and NANSA. Work undertaken has included wildlife surveying, heathland management and path maintenance. Progress has also been made with the Mousehold Heath Earth Heritage project.
- 2. Following its winter repair, the Vinegar Pond has continued to hold water (even during the very dry period in March) and the frogs have had a successful breeding season.
- 3. Despite the unsettled spring weather, the following events were run by the Mousehold Heath wardens with number of attendees in brackets.

The natural areas officer, Paul Holley, will retain a specialist advisory role on wildlife and land management issues and will contribute to the work of the Mousehold Conservators when required.
