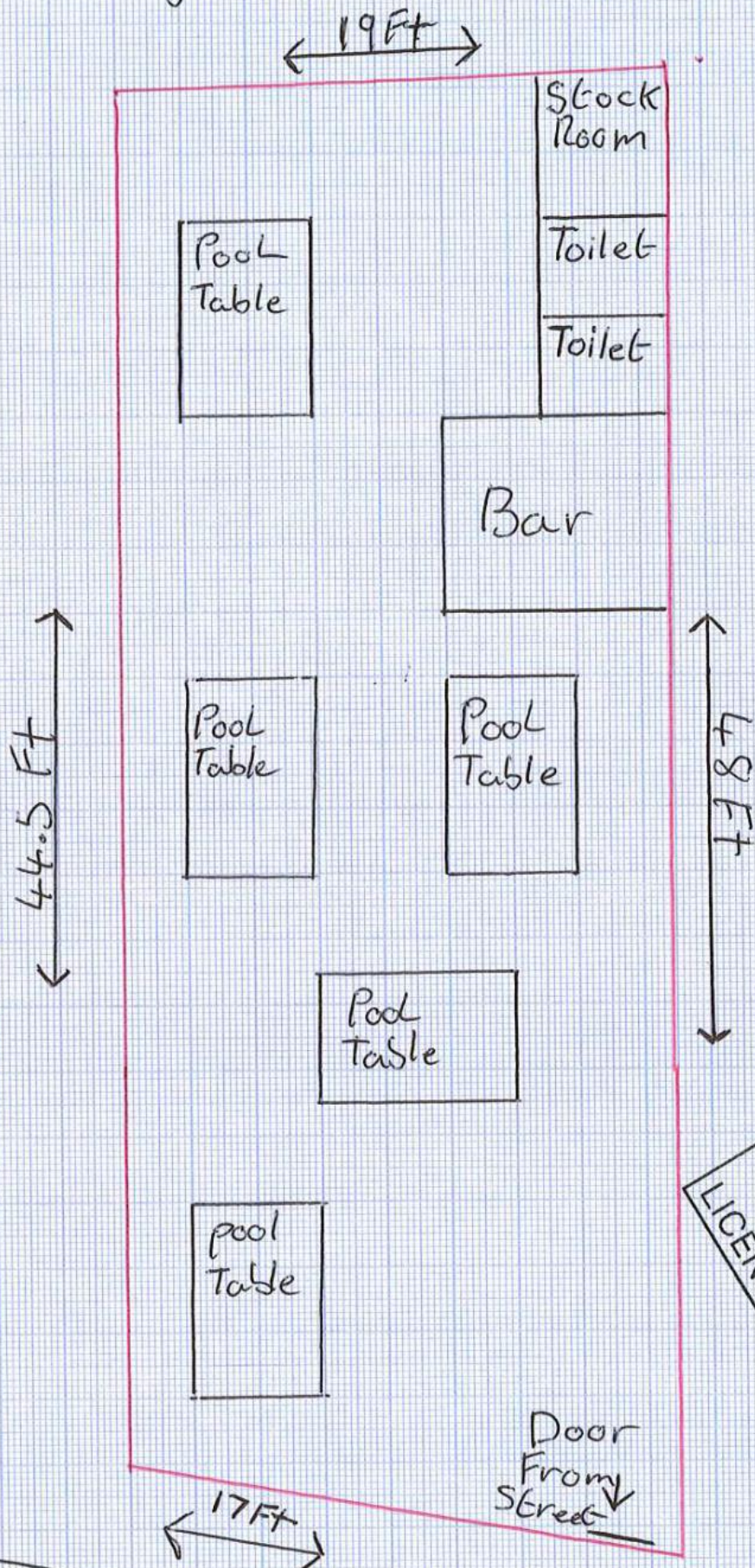

Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
  - Live music: no licence permission is required for:

Dear Sir/Madam

I can confirm that Norfolk Constabulary has been consulted on the application for a new premises licence for 2A Sprowston Road Norwich.

The applicant is Colin Shreeve, and this application is to allow for indoor sporting events with the sale of alcohol for consumption on premises from 10:30am -Midnight Friday and Saturdays and 11am-11pm Sunday, Monday-Thursdays.

Following discussions with the applicant, I understand that the applicant is intending on withdrawing himself as DPS and nominating a family member instead. This family member will be working at the premises and a further DPS application will take place in due course.

The intention is to operate as a member pool club. In order to promote the licensing objectives, I would request that there are the following additions to the licence:

- **CCTV to be in operation at the premises. CCTV Cameras to record the main public areas of the premises and immediate outside. CCTV footage to record for a minimum of 28 days and be available to Police or Licensing Authority on request.**
- **There will always be one member of staff on duty who are conversant with the CCTV system when the premises are open for licensable activity.**
- **Staff will be trained in relation to the sale of alcohol. Training records will be kept at the premises and available to Police or Licensing Authority on request.**
- **Patrons will be prevented from taking open vessels of alcohol off the premises.**
- **The premises will operate a membership scheme.**
- **No person under the age of 18 will be permitted on the premises after 2030hrs.**
- **Signage will be on display reminding patrons to respect the neighbours.**

- **An incident log shall be kept at the premises and made available on request to an authorised officer of the Council or the Police, to include the following:-**
  - a) **All crimes reported to the venue**
  - b) **All complaints received.**
  - c) **All ejections of patrons**
  - d) **Any incidents of disorder**
  - e) **Seizure of drugs or offensive weapons**
  - f) **Any faults in the CCTV system**
  - g) **Any refusal of sale of alcohol.**

**With the change to the DPS and additional conditions added to the Premises Licence, there are no Police objections.**

Please give details of your support/objection in relation to at least one of the four licensing objectives	<p>TO PREVENT CRIME &amp; DISORDER: We have already had trouble with Class A drug dealing in this vicinity – and it's a possibility that this premises could increase the likelihood of drug use and dealing in the area. Recently, numbers of cars in the area have been vandalised. An establishment that is encouraging drinking all day from morning to late evening, 7 days a week, has the potential to increase crime and disorder locally, including vandalism to vehicles and property break-ins &amp; theft. As a result of both daytime drinking and the late night sale of alcohol at the premises on a daily basis, there is the real likelihood of an increase in anti-social behaviour and crime around our homes, such as littering (not least cigarette butts and vapes), vandalism, and even aggressive behaviour and violence. PUBLIC SAFETY: Because the premises is situated directly on the public highway, groups of people from the club –</p>

	<p>many certainly having been drinking – will undoubtedly be milling about outside on the pavement, smoking and vaping. I live on my own directly opposite the premises, and can imagine there will be times when this could feel intimidating, even threatening. This is a residential area, with many families. This is an entirely inappropriate proposal in terms of public safety in relation to this area. Sprowston Road is a main thoroughfare to and from the city, and there are many pedestrians walking past the premises. Pedestrians are going to be forced to walk out onto the road to get by, creating a public safety hazard from passing traffic (although it's 20mph, vehicles frequently speed). There is also potentially a risk to patrons of the club of a traffic accident when leaving the club (especially if some may be inebriated).</p> <p>TO PREVENT PUBLIC NUISANCE: Living directly opposite, I will undoubtedly experience an increase in noise disturbance and nuisance from customers (many of whom will have been drinking) entering and leaving the premises up to 11pm 5 days a week, and midnight Fridays and Saturdays; and potentially from the playing of music at the premises. Parking is already a big problem in the area and this will be further exacerbated by some patrons who will undoubtedly drive to the club.</p> <p>TO PROTECT CHILDREN FROM HARM: I would be particularly concerned about how the granting of this license might adversely affect all of our day-to-day living experiences, our homes and the local area. This is a residential area, with many families &amp; children living here. There will be drinking during the day – and likely increased evidence of inebriation - and smoking and vaping out on the street, which could be frightening and harmful to children (including those coming &amp; going to local schools, both primary and secondary), particularly if there is aggressive behaviour being exhibited. There could also be the possibility of drug dealing, which children and young people could also be exposed to. There is also the potential for increased risk of harm to children having to step into the road to avoid patrons on the pavement outside the premises.</p>

Upon reviewing the application on the Norwich City Council website, I have identified several critical concerns. The applicant's brief 48-word description of measures to promote the four licensing objectives is inadequate and lacks the necessary detail to address potential impacts on the surrounding community. Firstly, the application omits essential details regarding the promotion of licensing objectives on pages 15-16, which are left blank. This lack of information demonstrates a failure to comprehensively plan for public safety, crime prevention, and public nuisance</p>
--	--

mitigation. The claim that excessive drinking and substance abuse "won't be tolerated" is vague and unsupported by specific strategies, rendering the mention of CCTV insufficient without detailed implementation plans. Moreover, there are inconsistencies within the application regarding the use of recorded music. While page 4 does not list recorded music as a licensable activity, page 16 indicates its presence. This discrepancy raises concerns about the applicant's understanding and management of noise levels, particularly late at night, to avoid disturbing local residents. The application also fails to provide clear measures for managing patron numbers and preventing loitering, which could lead to public nuisance. The lack of a strategy for identifying underage individuals to prevent alcohol service is another significant oversight. I am particularly concerned about the potential increase in public nuisance and crime that could arise from granting this license. Noise disturbances from music and patrons, littering from smoking/vaping outside, and the risk of property damage from loitering are serious issues. The encouragement of a late-night drinking culture may further exacerbate violent crime in the area, which is a deeply troubling prospect for local residents, including myself. Additionally, the area is already adequately served by numerous licensed premises offering similar activities, such as The Stanley, Danomey's, The Brewery Tap, The Prince of Denmark, Urban Bull Lounge, The Artichoke, The Marlborough Arms, The Cottage, The Malt and Mardle, The King's Head, and Riley's Sports Bar on Magdalen Street. Given this context, the need for another licensed venue is questionable. Parking issues on Sprowston Road and adjacent streets are also a significant concern. The development at 2A Sprowston Road has already exacerbated parking problems, with illegal parking and encroachment on permit spaces. This situation forces traffic, including buses, to mount the pavement, endangering pedestrians. The addition of another venue will likely worsen these conditions. In light of these concerns, I urge the Licensing Authority to carefully consider the potential negative impacts on the community and deny this application. Thank you for considering my objections.
