Subject Disability Discrimination Act works required at off-street car

parks

Purpose

To seek approval for the allocation of funds to carry out adaptations and essential maintenance and repairs at the council's income generating public off-street car parks. These works are required in order for the council to continue to comply with its responsibilities under the Disability Discrimination Act 2005.

Recommendations

- To approve the allocation of funds as set out in *Appendix A* for the current financial year and to note the proposals for 2011/12 and 2012/13 financial years; and
- 2. To delegate to the Director of Regeneration and Development and the Head of Finance, in consultation with the Portfolio Holder for Corporate Resources and Governance authority to determine the arrangements for funding the expenditure proposed for 2010/11.

Financial Consequences

The City Council generates significant income from parking fees and charges currently projected to be £4.59m for 2010/11.

The council's ability to continue to generate this level of parking income in an extremely competitive market and to meet its responsibilities under the Disability Discrimination Act is entirely dependent upon sufficient funds being available to adequately maintain and re-invest in its car parks.

This in-year additional expenditure will need to be funded from existing resources including income and this is a matter to be determined by officers in consultation with the relevant portfolio holder.

Risk Assessment

The council has an obligation under the Disability Discrimination Act to carry out reasonable adaptations to its car parks and to ensure that they are accessible by all.

The Council has carried out an update to its accessibility survey and has identified a range of works which are required now (current financial year) and others that will be necessary over the subsequent two financial years.

These works are vital for the council to continue to be able to comply with its responsibilities under the Disability Discrimination Act 2005. Failure to carry out necessary works could result in the council being prosecuted under the DDA with associated costs and adverse publicity.

Currently there is no budgetary provision for the works identified within this report.

Strategic Priority and Outcome/Service Priorities

The report helps to meet the strategic priority "Opportunities for all – communities to be able to access the wide range of services in the city provided by the Council" and the service plan priority to establish funds to adequately re-invest in its income generating assets.

Background

- 1. The Disabilities Discrimination Act 1995 made it unlawful to discriminate against a person on the grounds of disability. The act requires that service providers (the Council) should from October 2004 make 'reasonable adjustments' in relation to the physical features of the building/premise to overcome physical barriers to access.
- 2. A council wide premises accessibility survey was carried out in 2002 which resulted in some DDA works being carried out between 2003 and 2005, including works to off-street public car parks.
- During July and August 2009 prior to charges for blue badge holders being introduced, works required to make payment machines compliant with BS 8300:2009 and Department for Transport guidance were carried out at Chantry, Chapelfield East, Pottergate, Magdalen Street and Rouen Road car parks.
- 4. In August of 2009 the council introduced charges for blue badge holders at five of its pay and display car parks in order to:
 - Treat all customers equally
 - Ensure sufficient income was generated to fund budgets for maintenance and reasonable adaptations
 - Ensure car parks were not lost prematurely to redevelopment through reduced capitalised values of land for car park use
- 5. The introduction of these charges is projected to increase income by £50k to £70k over a full financial year.
- 6. Additionally officers have been able to negotiate a reduction in its ongoing car parks business rates liability in excess of £20,000 pa with a back dated rebate to cover the period from 2005 through to 2010 of £106,000
- 7. During April and May 2010 an update to the car parks element of the premises accessibility survey was undertaken. This work was undertaken following consultations and a meeting with the Norfolk Coalition of Disabled People, the Norwich Access Group and representatives from Mobilise a charity based in Norfolk which represents the interests of disabled people.

Survey objective and findings

- 8. In assessing the various access issues the council's surveyor used as his criteria current good practice derived from the following recognised authorities:
 - Centre for Accessible Environments (CAE)
 - BS 8300:2009 Design of buildings and their approaches to meet the needs of Disabled people – Code of practice
 - Part M Building Regulations

- Department for Transport Guidance
- 9. The primary objective of the surveys was to highlight the physical access constraints present in the car parks and make recommendations for improvement (taking into consideration the requirements of the DDA).
- 10. A summary of the estimated cost of works identified for each car park is laid out in *Appendix A* and a breakdown of the nature of those works forms *Appendix B*.
- 11. Total revenue funds of £359,050 and capital funds of £171,500 now need to be allocated to ensure that the Council complies with its statutory responsibilities over the next 3 years and to support the resolutions made at Executive 24 June 2009 and NHAC 25 June 2009.
- 12. It is recommended that members approve the allocation of funds as summarised within Appendix A and B
