Background

- 1. Parking Services has carried out civil enforcement of parking restrictions in Norwich since 2002.
- 2. Due to legislation changes and to clarify the council stance on enforcement it is now appropriate to update our Parking Policy.
- 3. On 7 November 2011 Norfolk Parking Partnership (NPP) began civil enforcement of parking restrictions in the whole of Norfolk except for Norwich.
- 4. NPP have adopted a Civil Parking Enforcement Guidance Manual which gives their statement of intent, enforcement procedures and decisions on parking charge notice (PCN) discretions.
- 5. Norwich is part of Norfolk Parking Partnership (NPP) and has been working with Norfolk County Council in preparation for civil enforcement in Norfolk. During this process Norwich officers have assisted with the development of the Civil Parking Enforcement Guidance Manual.

The way forward

- 6. It would be beneficial to the public for enforcement of parking restrictions in the whole of Norfolk to be uniform.
- 7. To achieve this it is suggested Norwich should adopt a new parking policy that states our intent for enforcement and our acceptance of the NPP Civil Parking Enforcement Guidance Manual.

Norwich City Council Parking Enforcement Policy January 2012

Statement of Intent

Norwich City Council will enforce parking regulations fairly, lawfully and without discrimination. It will organise this enforcement in a manner that is proportionate to the need for traffic management in Norwich.

In partnership with Norfolk Parking Partnership, Norwich City Council will adopt the Norfolk Parking Partnership Civil Parking Enforcement Guidance Manual November 2011 and any subsequent amendments.
