#### **Background**

- 1. This is one of a series of reports that have been produced regularly since 2008. The purpose of this report is to ensure members are aware of the outcome of planning appeals.
- 2. Appendix 1A provides details of appeals lodged which are pending. There are seven planning appeals pending or awaiting decision. Three of these appeals were delegated officer decisions where the application was refused. Three appeals (application no. 12/01120/VC for moorings at King Street and which will be determined by the hearing process, application no. 12/01487/F for 66 Wellington Road, application no. 12/01245/F for 126 Cambridge Street and a report on a new, identical application is also referred to this meeting) were all cases where members overturned the officer's recommendation and refused the application. The remaining appeal (application no. 12/00961/F for the car park site at rear of 5 to 11 Cathedral Street) was a case where members refused the application in line with the officer's recommendation.
- 3. There were four appeals dismissed during this quarter (Appendix 1B). The cases being application number 12/00658/F (Georgian House Hotel, 30 to 34 Unthank Road); application number 12/01011/T (1A Portersfield Road); application number 12/01423/F (3 Wakehurst Close) and application number 12/01673/F (20 Lime Tree Road). All four applications were delegated officer decisions where the application was Refused.
