**Subject** Review of Polling Districts, Polling Places and Polling

**Stations** 

## **Purpose**

To review Polling Districts, Polling Places and Polling Stations as required by the Representation of the People Act 1983 (as amended by the Electoral Administration Act 2006) and the Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006.

#### Recommendations

- (1) To maintain the current Polling Districts, Polling Places and Polling Stations subject to:-
  - (a) changing the Polling station in Polling District TC4 to the 6<sup>th</sup> Form Centre, Norwich High School for Girls, Newmarket Road.
  - (b) changing the boundary of Polling District TH5 to follow the river and adding the area south of the river to TH3
- (2) To ask the Returning Officer and Democratic Services Manager to continue to keep the scheme under review to ensure that each polling district has the best possible polling station available for each future election.

## Report

#### Introduction

- 1. The Representation of the People Act 1983 (as amended by the Electoral Administration Act 2006) and the Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006, requires that Norwich City Council conducts a review of polling districts, polling places and polling stations in its area.
- 2. Local authorities are required to divide their area into polling districts for the purposes of parliamentary elections and to designate polling places for these polling districts, and to keep these under review. By conducting this statutory review of polling places, local authorities must demonstrate that they have, as far as is practicable, met the following criteria set out in legislation.
  - a. seek to ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances
  - b. seek to ensure that so far as is **reasonable and practicable**, the polling places they are responsible for are accessible to all electors, including those who are disabled, and when considering the designation of a polling place, must have regard to the accessibility needs of disabled persons.
- 3. In an ideal world Council's would have the choice of a range of fully accessible buildings, conveniently located for the electors in the area. It is accepted, however, that in practice this is not always the case and there may be little choice available. If it is necessary to use a place where for example, the access is not ideal, then every reasonable adjustment must be undertaken to provide access for all electors.
- 4. The key things local authorities are required to bear in mind when conducting this review is that all decisions made must be consulted upon, measured, and practical. The whole process should be as transparent and open as possible to avoid possible conflict.

### Review of polling districts, polling places and polling stations in Norwich.

- 5. The review was advertised in the press, on the Council's website and a public notice displayed in City Hall. Details of the current polling districts, polling places and polling stations are always available on the Council's website and details/plans were also made available for personal inspection at City Hall. The consultation period was from 18 July to 2 September, 2011.
- 6. Invitations to contribute to the review were sent to MPs, MEPs councillors political parties, Broadland District Council and disability groups. A full list of those directly consulted is attached as Appendix A.

## **Polling Stations**

- 7. The list of polling stations is attached as Appendix B. All polling stations have been inspected and assessed to ensure that they are fully accessible. In some cases this is possible by providing ramps on day of the poll.
- 8. Comparator data which shows the changes to the number of electorate in each polling district since the last review is attached as Appendix C.

## **Polling Districts Review Group**

9. A cross party review group was set up with the following terms of reference:-

"The Polling Districts Review Group will consider options relating to Polling Districts, Polling Places and Polling Stations; consider representations received and make recommendation to Council as required by the Representation of the People Act 1983 (as amended by the Electoral Administration Act 2006) and the Review of Polling Districts and Polling Places (Parliamentary Elections) Regulations 2006."

- 10. The review group met on Monday 12 September, 2011 and was informed of the following representations received within the consultation period:-
  - An elector commented on the polling station at St Catherine's Church and supported this as the best option available. The other comments contained in that representation related to parliamentary boundaries which are being considered nationally as part of a separate boundary review.
  - The Returning Officer, who is expected to formally contribute to the review, submitted a letter which is attached at Appendix D. His response reflects the fact that the polling stations are reviewed prior to every election according to availability and he is fully involved in that process. He is happy with the current scheme and his only proposal is that in Polling District TC4 the squash court at East Anglia Tennis Club, Lime Tree Road be replaced as a polling station by the 6<sup>th</sup> Form Centre at Norwich High School for Girls, Newmarket Road.
- 11. The Returning Officer and the Democratic services officer emphasised to the review group that continuity was very important. People become used to where they vote and despite all appropriate and statutory notice of change, including poll cards etc, many become confused when change becomes necessary due to unavailability of the regular building. It was, therefore, very important when considering any change to polling arrangements, to be sure that there was clear evidence that the change would benefit the majority of the electorate.

## 12. Review group members highlighted and debated the following areas :-

#### Town Close Ward

The Returning Officer explained that his proposal for changing the polling station in Polling District TC4, as detailed above, was based on duty of care for polling station staff who had to work for up to 15 hours with no natural light with the constant noise of squash balls bouncing off the wall of the connected squash court.

#### Lakenham Ward

A member suggested merging Polling Districts LA1 and LA2 as the two polling stations were close together. Another member said that this had been suggested at the previous review but Council decided that the current arrangements should remain as the two areas were distinct and separate communities.

## Thorpe Hamlet Ward

It was suggested that TH5 was a very large district and for those people living south of the River Wensum it was easier to go to the polling station in TH3 which was closer and easier to drive to. It was reported that the Norwich Labour Party, one of the formal consultees, also supported changing the polling district boundary of TH5.

The Returning Officer agreed that changing the boundary of TH5 to follow the river and adding the area south of the river to TH3, would make access easier for the electorate living south of the river; give a more even distribution of the electorate between polling districts and take into account possible future development.

#### Mancroft Ward

It was reported that Norwich Labour Party had suggested changing polling arrangements in this ward as residents in the south of MA5 had a long way to go to the polling station at Chantry Hall. Introducing a new polling station in the south of the polling district would be beneficial.

It was acknowledged by members that MA5 was a large geographical area but that the current polling station was central. Any change in polling stations would have advantages for some but disadvantages for others. Also, due to the nature of this city centre ward, changing district boundaries was difficult due to the layout of major roads. The returning Officer said that he would keep this area under review.

#### Wensum

A member said that the Norwich Labour Party had also expressed concern that there was no dedicated polling station in WE3. The Returning Officer said he had personally had several contacts with the organisation that used the old polling station but for their own operational reasons, they were unwilling to allow it to be used. The Democratic Services Manager said that officers had searched for alternatives in WE3 but none were suitable and available. Sites within the Bowthorpe Hospital had been considered but those offered were difficult to access within this large site and there was no long term certainty the same spaces would be available in future. Operating a double polling station in WE2 was currently the only available option. However, the search would continue and if any suitable premises become available, they will be utilised.

## **Polling District and Places Review 2011**

This letter sets out my views as Returning Officer for Norwich by way of response to the above consultation exercise currently in progress.

I have been in post since 2009 and I have seen the review which took place in 2007.

Since 2009, I have been the Returning Officer in Norwich responsible for a general election, two council-wide local elections and a national referendum. During this time, it has been necessary to carefully assess polling district and station requirements. Whilst the relatively small geographical size of the area has meant that options are limited, a small number of changes to polling stations have been necessitated by local circumstances. In effect therefore the lead up to each election warrants a review in itself. By way of example in May 2011 we were able to utilise the Community Room at Larners Way, removing the need to have two stations at the Norman Centre on Bignold Road (MX2/3) which had been used since the loss of the longstanding polling station at the former Mile Cross Primary School on Valpy Avenue. In future I would also expect to seek to utilise a new building at Norwich High School for Girls in Newmarket Road as a more suitable venue for a polling station as opposed to the current polling station East Anglia Tennis and Squash Club in Lime Tree Road (TC4) where the voting takes place in the squash court itself.

There are some minor variances in total electorate within different Polling Districts. However, these are well within the parameters that allow me to undertake an efficient election and accurate count.

Subject to these general comments, the ongoing review (and the one specific proposal), I consider the current polling district and polling station provision to be appropriate for the prevailing circumstances in Norwich.
