Annex 1 – Mandatory conditions

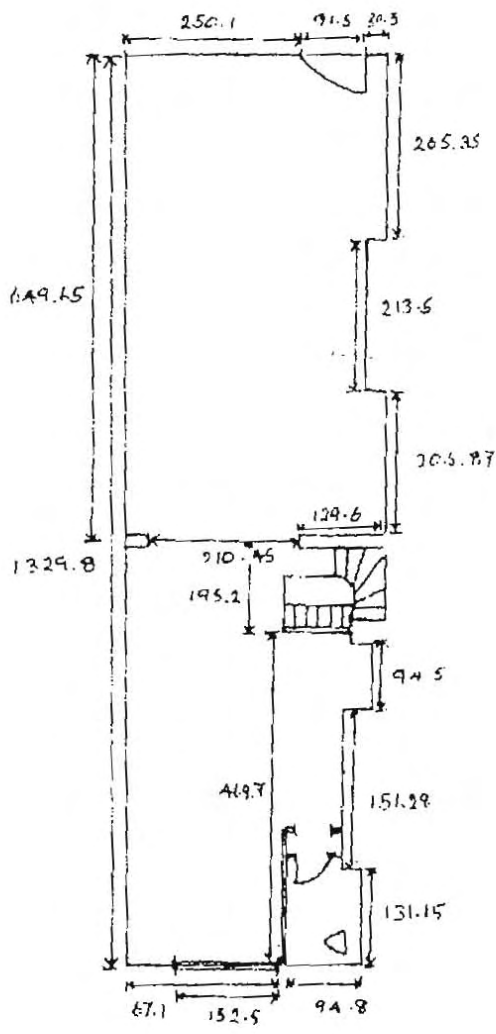
- 1 No supply of alcohol may be made under a premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2 Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3 Where, at specified times one or more individuals must be at the premises to carry out a security activity each such individual must be licensed by the Security Industry Authority.
- 4 Where previous licence is "off licence" or "off sales" alcohol shall not be sold or supplied except during permitted hours.

The following restrictions are not prohibited:

- a) During the first twenty minutes after the above hours, the taking of the alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- b) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- c) The sale of alcohol to a trader or club for the purposes of the trade or club;
- d) The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces; supplied except during permitted hours.

Annex 2 – Conditions consistent with the Operating Schedule

- 1 **General - all four licensing objectives**
- 2 A Refusal Book will be kept on the Licensed Premises recording instances where a sale has been declined or refused.
- 3 **The Prevention of Crime and Disorder**
- 4 A 24 hour CCTV recording system will be maintained on the premises by the Licensee.
A telephone line will be maintained on the premises so that Police may be contacted.
During busy periods a Doorman will be present.
- 5 **Public Safety**
- 6 The Licensee will ensure that all electrical and fire safety equipment will be checked at regular intervals.
- 7 **The Prevention of Public Nuisance**
- 8 All deliveries to the premises will be made during daytime period.
- 9 **The Protection of Children From Harm**
- 10 A photographic Proof of Age scheme will be enforced by the Licensee and appropriately trained staff at all times.



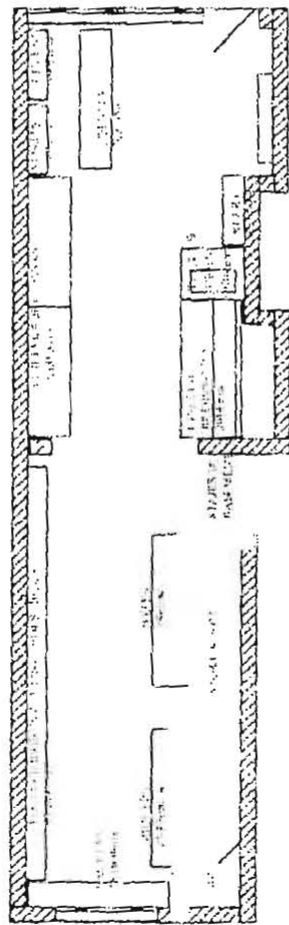

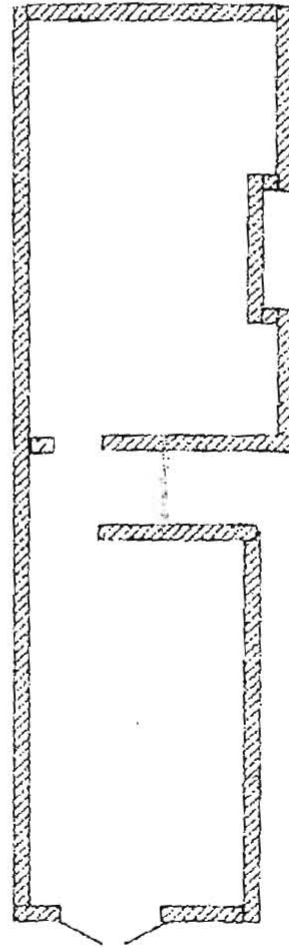
