Purpose

Members are asked, in accordance with the delegation of licensing functions contained in the Norwich City Council Statement of Licensing Policy (Licensing Act 2003), to consider the application for the grant of a premises licence in respect of Last Pub Standing, 27 – 29 King Street, Norwich NR1 1PD following the receipt of relevant representation.

Recommendation:

It is recommended that members determine the application to grant the premises Licence in accordance with the:

- Licensing Act 2003 and subsequent regulations
- Guidance issued under Section 182 of the Licensing Act 2003; and
- Norwich City Council Statement of Licensing Policy

Report Details

The application

- 1. The applicant is Last Pub Standing Limited and the proposed DPS is Simon Peters.
- The application seeks to allow the licensable activities, times and opening hours as set out in the application form, which is attached at appendix A. This also includes the steps proposed to promote the licensing objectives (operating schedule).
- 3. This premises was previously licensed however, the premises licence holder went into administration and the licence lapsed. TEN applications have been granted to enable some trading.

Summary

- 6. The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - Grant the application as asked;
 - Modify the conditions of the licence by altering or omitting or adding to them;
 - Reject the whole or part of the application;
 - Refuse to accept the proposed DPS.
- 7. The sub-committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.
- 8. The representation received appears to relate to issues that fall under the licensing objectives.

The Prevention of Crime and Disorder

- 1. There shall be no admission to the premises after 00:00.
- 2. A No ID, No Entry scheme is to operate on Thursday, Friday and Saturday to anyone who appears to be under the age of 21 years.
- 3. CCTV will be installed both inside and outside the premises to cover exit points.
- 4. Sufficient staff will be on duty to be able to monitor patrons inside the premises and when they leave.
- 5. The DPS is to become a member of Norwich Pubwatch and Norwich Licensing Forum and to attend a minimum of three meetings of each a year.

Public Safety

6. Function bookings will be limited to 100 persons.

The Prevention of Public Nuisance

- 7. Live music will end at 00:30.
- 8. Recorded music will end at 01:00.
- 9. The recorded music volume will be reduced to background level decibels after 00:30.
- 10. All windows will be closed after 00:00.

The Protection of Children From Harm

11. Children will be discouraged from the bar area and are only permitted in the garden area.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination** with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
 who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
 the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at https://www.gov.uk/prove-right-to-work) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.



Good Morning Maxine,

In light of the ongoing noise complaints I will have to raise an objection to this licence under the prevention of public nuisance.

In the past 4 months, Environmental Protection have received 2 noise complaints regarding Last Pub Standing (one of which is still live) and spoken to pub management on late night visits on two occasions where the music outside was deemed to be excessively loud.

I also have concerns given the lack of compliance with the previous premises licence. Mr Peters was visited by myself and Peter on the afternoon of Thursday 9th November where it was explained clearly that the previous licence was no longer valid and they were no longer able to trade. Advice was given that TEN's would need to be submitted to try and cover the period between 9th November and when a new licence is granted so they would be able to trade for at least some of the time. I believe this instruction was clearly understood by Mr Peters as TEN's have now been received. I was then disappointed to see that Last Pub Standing had decided to continue to trade after our visit despite knowing that they did not hold a valid licence.

Whilst I am happy to have discussions with Mr Peters over conditions surrounding live/recorded music in the venue, I would still have concerns over whether he would indeed comply with any conditions imposed.

To whomever this may concern,

I am a resident living in Greyfriars Road, the building behind the Last Pub Standing and I have lived here for over a year.

I would like to share with you my experience of living behind this establishment. Ever since my partner and I moved to this building in August 2022, we have been constantly disturbed by the extremely loud music played by the Last Pub Standing. The windows in our flat vibrate when have their events and play music in their garden. This is a residential area, this pub has a residential building both in front as well as directly behind it. There are families with young, small children who go to school. Myself personally, as a working adult, have found it extremely challenging and I have truly struggled to sleep the weekdays the pub plays their ungodly loud music, as well as during the weekends, when one is meant to unwind and manage to relax. It has caused my partner and I severe stress and anxiety, not to mention the quality of our lives has been significantly impacted and decreased due to lack of sleep and rest. It has also impacted my physical health due to the fact I am not getting enough sleep and rest, my immune system has taken a hit and this has been a contributing factor in my health declining during this past year and a bit since moving into this building.

My partner and I have a young 2 year old child. The Last Pub Standing has been playing and wants to continue playing music until 12am on Fridays and 1am on Saturdays, according to their previous schedule and their new licence application. To have a 2 year old child try to fall sleep to extremely loud music and disturbance is challenging and difficult for the child, and she displayed extreme discomfort and anxiety in being unable to go to sleep at her usual bedtime, which is around 7-8pm. This causes my partner and I high stress and anxiety, too. These are formative years of a child's life, and this obnoxiously loud music played carelessly by the Last Pub Standing poses a real threat and danger to our child's normal development, both physically and cognitively. I am sure my partner and I are not the only parents who struggle with this issue. I see lots of young children with their parents in our building every day, and I am sure their lives are just as negatively impacted by the careless actions of the Last Pub Standing.

The Last Pub Standing was operating without a licence, which only suggests they do not care much for the community surrounding their establishment nor our wellbeing and are simply concerned with continuing in their way for their own benefits.

I have made complaints to the council which have lead to noise monitoring equipment being installed. These recordings and monitoring of the extremely loud music and noise coming from the Last Pub Standing have been so significant that the city council has deemed it as statutory nuisance and decided to serve the Last Pub Standing with an abatement notice. I very strongly object for the Last Pub Standing's licence application to be approved as it is harmful to our community and I would be most grateful if my objections in this email would be carefully considered and listened to, as I am very confident I am not the only member of our community or the only person who lives in this building to agree in saying this licence application should not, under any circumstance, be approved.
