**RESOLVED** to appoint Councillor Brociek-Coulton as the council's representative and Councillor Stutely as substitute to the Norfolk Health Overview and Scrutiny Committee.

# 6. Appointment of the member and substitute member of the Norfolk Countywide Community Safety Partnership Sub Panel

**RESOLVED** to appoint Councillor Vivien Thomas as the representative and Councillor Stutely as the substitute to the Norfolk Countywide Community Safety Partnership Sub Panel.

## 7. Terms of reference for scrutiny select committees

The chair presented the report. Members discussed the need for clear guidelines and expectations on who would be responsible for drafting reports and how information could be gathered by any select committee.

The monitoring officer suggested the following amendments:-

To amend point e) under "expectations on the Chair of the group" to read "Presenting reports of the group, including progress reports to the appointing committee"

To add the following under "Methodology and timeframes": "Expectations with regards to written reports, including how it should be produced".

To add the following under "Methodology and timeframes": "What information will be required to provide an evidence base for the group and how this will be sourced".

## **RESOLVED** to:

- 1) Amend the terms of reference for scrutiny select committees as suggested by the Monitoring Officer; and
- 2) adopt the amended terms of reference for scrutiny select committees.

## 8. Scrutiny work programme 2022-23

The chair presented the report and highlighted that the informal workshop, held on 26 May, had been successful in shaping a draft work programme. The work programme was a standing item on the scrutiny committee agenda, so changes to the work programme could be made throughout the year.

Members discussed the October meeting in particular with regard to the topic of County Lines. Members commented that in their view County Lines should be the priority. A member commented that County Lines and Anti-social behaviour were intimately linked. The executive director of community services highlighted that a community safety strategy was being drafted which would take a holistic look at the way in which residents' safety would be impacted. She added that it would be helpful for the committee to pre-scrutinise this strategy. Members discussed that the work on County Lines would need to be fully scoped.

Members discussed the topic of welcoming refugees with a view to considering this earlier in the civic year. It was agreed that the piece of work would need to be fully scoped before the September meeting of the committee at which members would decide whether a select committee would be the most appropriate mechanism for this topic.

Ideally one substantive item per meeting would be the aim.
- 6. Members are able to revise the work programme on a month basis if and when required due to changing events. This is done through the work programme standing item at each meeting. Members therefore may wish to consider keeping some space on the work programme to facilitate this.
