1. Appointment of chair

RESOLVED to appoint Councillor Grahame as chair for this meeting.

2. Declaration of interests

There were no declarations of interest.

3. Minutes

RESOLVED to approve the accuracy of the minutes of the meeting held on 8 July 2016.

4. Whistleblowing guardians

The democratic services manager presented the report. He said that the Norwich City Council Whistleblowing Policy was only for staff matters and the member code of conduct was to be used for complaints against members.

There was a specific process to be followed if a member of the public lodged a complaint against a councillor.

Peter Franzen said that the NHS had moved away from whistleblowing. Concerns needed to be able to be raised without fear of retribution. He added that the role of the whistleblowing guardian could be of use to councillors who wanted to raise concerns within their group.

The democratic services manager said that this happened organically with councillors approaching him directly in the first instance. His role was only to give advice, after speaking to the democratic services manager; councillors could deal with this issue themselves or make a formal complaint to the monitoring officer.

RESOLVED to:-

- 1) not include whistleblowing guardians in the member's code of conduct; and
- 2) ask the democratic services manager to consider formulating guidance for officers and members on who to contact with initial concerns regarding member's conduct.
