To prevent crime and disorder	This shop already causes an unacceptable amount of crime and disorder with its current opening hours. The shop being open until 4am on weekdays will make life unbearable for us as people buying drink from here at that time of night/morning do not be take it home to drink, IT IS FOR CONSUMPTION IN THE STREET, usually opposite our house (on the wall of Horsefair House). Drinking in the street is illegal and by allowing this off-licence to trade in the early hours of the morning, the Council is actively encouraging illegal activity. Obviously, people drinking in the street cause anti-social behaviour. They shout loudly, urinate in our garden, yell abuse if we complain and throw empty bottles and cans into our garden. We have called the Police on numerous occasions to remove people who are consuming drink purchased from Bootleggers and causing a nuisance. We know drink has been purchased from Bootleggers as nowhere else in the area sells drink at that time of the morning. The Police will have a record of these many incidents. It is bad enough having to put up with anti-social behaviour at the weekends but having people shouting outside until gone 4am on work days would make life impossible.
Public safety	There have been occasions where we have called the Police but they haven't been able to attend so we've asked people to keep the noise down and pointed out the 'No Alcohol Zone' signs that are clearly displayed. We have been threatened with being beaten up and having our house burnt down. If people look particularly 'dodgy', we daren't even say anything for fear of retribution.
To prevent public nuisance	Please see comments above under 'To prevent crime and disorder'. We feel that if this licence is granted, it will escalate the already huge problem and it will have a detrimental impact on the value of our property which will become unsaleable. Planning permission was granted, by the Council, for housing in this area so it has been deemed suitable for residential use. We feel that the Council has a responsibility to protect our quality of life rather than heap further misery on us by allowing an all night street beer garden every night instead of just at weekends.

To prevent crime and disorder	Objection: This is an area classified by the Police as one of 'high level of crime'. Residents in Cathedral Street and Saint Faiths Lane are already badly affected by drunk and disorderly behaviour as people tend to congregate opposite our houses where they can sit on a wall or at Horsefair Green, drinking. The problem is worse at week-ends. We have often had to contact the Police about this and on one occasion recently needed to call an ambulance as a man was so drunk he could not be roused.
Public safety	Objection: At week-ends the area around St. Faiths Lane and Horsefair Green is littered with bottles (often broken) and beer cans. The behaviour of people who drink alcohol bought in shops feels theatening. These problems are less severe on week-days.
To prevent public nuisance	Objection: The noise level is such that residents are frequently disturbed at night. This would increase further if a licence was granted to sell alcohol every day of the week until 4 a.m.
To protect children from harm	Objection: Saint Faiths Lane is used by young children and students from the Norwich School (walking to and from their sports hall) who are at risk from cuts by broken glass. The sight of bottles and cans is of course not pleasant and sets a bad example to the children.

Please suggest any conditions which would alleviate your concerns.	None. We are extremely concerned about the prospect of even more opportunity being given to people to buy alcohol throughout the night which they then bring to Cathedral Street and Saint Faiths Lane. We have been working closely with the Police and Community Liaison Officers to deal with the problem and an extension of the licence for selling alcohol would make matters very much worse. Please do not allow this to happen.
