### Scrutiny committee work programme 2019-20

<b>Summary:</b>	The purpose of this report is to assist committee members in setting the work programme for the rest of the civic year 2019-20.
<b>Conclusions:</b>	<p>It is proposed that any discussion is agreed as a whole committee using 'TOPIC' criteria. This will assist members in achieving the goal of an agreed work programme that is met by consensus.</p> <p>The programme is a standing item at each committee meeting and can be adjusted as necessary.</p>
<b>Recommendation:</b>	<p>To:</p> <ol style="list-style-type: none"><li>1) consider the scrutiny committee work programme 2019-20;</li><li>2) note the chair's response to a letter on a topic submitted by a member of the public, attached at appendix 1;</li><li>3) agree dates for the two select committees to feedback to the scrutiny committee; and</li><li>4) to agree to remove the UBI item from the work programme.</li></ol>

## Report

1. When the scrutiny committee considers which items to include on its work programme, it is useful to do so in the context of what the focus is for the council over the coming year and to look at how activity aligns to the council's corporate plan.
2. This is so that the scrutiny committee will be able to consider where and how it can add value to the work being carried out towards achievement of the council's priorities and ensure that resources are being focussed effectively.
3. Although sometimes not possible to achieve, it was previously agreed that the committee should agree as few as possible substantive topics per meeting. The main reason for this is to ensure that there is enough time for the committee to effectively consider the issues and has a fair chance of reaching sound, evidence based outcomes. Ideally, one main item per meeting would be the aim.
4. Although the future work of the committee has been set up to March 2020, members will have the opportunity on a monthly basis to revise the programme if and when required or due to changing events.
5. Along with this report, members have a copy of the cabinet forward agenda for consideration.
6. It is proposed that any discussion is as a whole committee using the TOPIC criteria. This will assist members in achieving the goal of an agreed work programme that is met by consensus.
7. Members are asked to agree to remove the Universal Basic Income (UBI) report from the work programme scheduled for 19 March. Members attended a briefing on UBI, on 11 November 2019 during Living Wage Week with a guest speaker from the Sheffield UBI pilot project.
8. Members are invited to see the response (attached at appendix 1) from the chair of scrutiny to a request from a member of the public for scrutiny to review the compliance of the design of cycle facilities on Rose Lane and Prince of Wales Road with the London Cycle Design Standards.
9. The Local Anglia Enterprise Partnership (LEP) are not able to attend scrutiny committee on 19 March 2020. Councillor Alan Waters, Doug Field, LEP chair and Chris Starkie, LEP chief executive officer confirmed they will be pleased to attend if a mutually convenient date is found. The scrutiny liaison officer attended the scrutiny committee at county hall on 17 December when the LEP was the topic. A list of questions directed to the LEP by Norfolk County Council Scrutiny committee members was circulated by the scrutiny liaison officer and members are reminded that the minutes from that meeting will be available on the County Council website.

10. Members agreed that the young people and wellbeing topic would be re-scheduled prior to March 2020. The scrutiny liaison officer is currently negotiating a date that the Stage 2 venue are host this.
11. Members are asked to agree dates for the report back from select committees for the topics below:
  - Anti-social behaviour including fly tipping and city council processes.
  - The growth of short term lettings of homes in Norwich with input from the Independent Hoteliers Group.
12. The equality information report was scheduled on the scrutiny committee agenda for 12 December 2019, this meeting was cancelled due to the General Election. Instead it was agreed that this report will be published on eCouncillor when available and a link will be sent to scrutiny members inviting questions and queries to be sent to Adam Clark, strategy manager.

Dear Mr Jennings

Thank you for your request to scrutiny dated 23 September 2019 regarding the continued use of the London Cycle Design Standards (LCDS) for pedalways throughout the city. I have now had the opportunity to consult colleagues in the transportation and network team at Norwich City Council and am able to respond as follows;

Back in March 2016 when it was resolved at scrutiny committee that the city council would commit to continue to use the LCDS funding for the pedalway programme, it was coming directly to the city council from the Department for Transport through the City Cycle Ambition grant (CCAG). This is no longer the case. The new cycle facilities on Prince of Wales Road have been provided by Norfolk County Council and are funded through the Transforming Cities fund. The city council continues to work with the county council over the implementation of highway improvements in the city, but no longer leads this work. I understand that regular liaison meetings with the cycle campaign (and other groups) during the design and development of the CCAG programme were valued, however the question as to whether these meetings should be resurrected would be one for the county council.

Additionally, given the question was asked to the scrutiny committee I did contact the county council on your behalf for an explanation of the design process and below is the response that I received;

*"The design of the stretch of cycle track along Prince of Wales Road from St Vedast Street to Eastbourne Place was originally designed with a 1.5 metre westbound cycle lane and a 0.8 metre margin between this and the adjacent parking bays, and in accordance with the London Cycle Design Standards. However when the design was safety audited concerns were raised around collisions between pedestrians and cyclists. Specifically the 0.8 metre buffer zone was too narrow for use by wheelchair users and offered very little margin for error for all pedestrians, increasing the risk of strikes from passing cyclists. The recommendation was to increase this pedestrian margin to 1.5 metres. As a consequence, the cycle track was moved further south with pinch points of 0.7 metres to 0.9 metres where the existing trees are located.*

*These cannot be removed and new ones planted further away from the cycle track given the numerous underground utilities along Prince of Wales Road. Instead it was agreed with the Audit team that the setts around the trees would be kept flush to maximise the width available. The edge detail alongside the cycle track was also kept flush to allow cyclists to use the full width up to the kerb face (some 3.0 metres) in the knowledge that some pedestrians will inevitably walk within the cycle track, and especially given the night time economy.*

*It is recognised that no further engagement has been held with the Norwich Cycle Campaign since a meeting with representatives was held on the 28th November 2018 to discuss the detail design. At this meeting the revised plan agreed at the NHAC meeting on the 20 September 2018 was discussed. It should be noted that the plan shows one of the pinch points to the tree along the stretch of cycle lane. This was not picked up as an issue at the time. The primary concern was to have a clearer route for cyclists through the open space, and this was included in the final design.”*
