The Call-in and members making the call-in

- The decision to delegate authority to the director of neighbourhoods, in consultation with the deputy leader and cabinet member for social housing, to award a contract for replacement kitchens, bathrooms and repointing in housing properties was made at cabinet on 13 September 2017.
