Report

Introduction

- 1. Central government guidance recommends that Local Planning Authorities keep their tree preservation orders under review.
- 2. Tree Preservation Order No 456 was served as part of the Councils review process. It consolidates and updates two existing tree preservation orders on The Walnuts, Branksome Road, by amalgamating them into one new document. The new order includes those trees which still exist on site and are subject to the earlier orders (tree preservation order no. 5 1964, and tree preservation order no.335 1999) plus some additional trees that have since established within the landscape and now contribute to the local amenity.
- 3. If TPO 456 is confirmed TPO No 5 & TPO No 335 will be revoked in order to conclude the TPO review process for this site.

Summary of objections

6. The objections are summarised below:

There was no prior discussion with the residents.	The serving of TPO 456 in order to review, rationalise and update the existing TPO cover was done with the knowledge of The Walnuts Residents Association. Interested parties can object and have objected to the serving of the Order.
There is no explanation of the decision to make the Tree Preservation Order.	The explanation of the decision to serve the Order was stated in the Notice and the letter that accompanied the Order when it was served in June 2012.
Was a right to light and air taken into consideration?	There is no right to light or air in respect to trees. Trees actively improve air quality locally.
The number of trees in the area is excessive.	The number of trees serves to enhance the setting of The Walnuts housing complex.
T4. does not directly affect those residents in favour of the Order.	Tree Preservation Orders are served in order to ensure that all the accrued benefits of those trees may be enjoyed by the wider public.
T4. reduction of light and sun warmth to adjacent house due to its proximity.	The tree is a Silver birch, one of the more delicately leaved species and as such is very suitable for such a setting and, at a 12mtr. distance from the property that is the focus of this particular objection, it is unlikely that there is any great detriment in terms of sun warmth or light obstruction.
Leaves block gutters.	There are proprietary products on the market that can help prevent the build up of leaf fall in gutters.
Pathway slippery in wet weather.	There is no identified direct causal link between the wet pathways and the trees.

Excessive moss on roof slopes.	There is no identified direct causal link between moss on roof tiles and the trees.
Detrimental effect on property resale value	Research has shown that properties in well treed areas benefit from a related increase in property values.
The description of G4 is inaccurate.	The description of G4 has been revised and the Order modified accordingly.
Cotoneasters are not trees, they overhang the adjacent garden and restrict its cultivation and affect the growth of apple trees there requiring annual trimming back of the overhanging branches.	The Order has been modified to exclude the tree Cotoneasters.
The Douglas firs in G4. are potentially unsafe.	All the trees on site are regularly inspected and any safety issues addressed by appropriate tree works.
Now that the Douglas firs are subject to the tree preservation order there is concern that the tree contractors who usually carry out the tree work will be reluctant to carry out any pruning thus increasing the risk of personal injury.	The Douglas firs have been the subject of a TPO since before the Walnuts was built. A TPO is not an impediment to good arboricultural management; on the contrary good management is encouraged. Any tree that becomes dangerous is exempt from the need to gain permission to carry out works necessary to make the tree safe.

Conclusion

7. Objections to the order have been taken note of and where appropriate the order has been modified. Confirmation of this order will simplify and rationalise the documentation.

FORM OF TREE PRESERVATION ORDER

TOWN AND COUNTRY PLANNING ACT 1990

THE CITY OF NORWICH TREE PRESERVATION ORDER NUMBER 456, 2012

The City Council of Norwich, in exercise of the powers conferred on them by Section 198 of the Town and Country Planning Act 1990 hereby make the following Order –

Citation

This Order may be cited as Tree Preservation Order, 2012
 City of Norwich Number 456; The Walnuts, Branksome Road, Norwich, NR4 6SR.

Interpretation

- 2. 1. In this Order "the authority" means the City Council of Norwich
- 2. In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning (Tree Preservation)(England) Regulations 2012.

Effect

- 3. 1. Subject to article 4, this Order takes effect provisionally on the date on which it is made.
- 2. Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or subsection (1) of section 200 (tree preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall—
 - (a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or
- (b) cause or permit the cutting down, topping, lopping, uprooting, wilful damage or wilful destruction of,
- any tree specified in the Schedule to this Order except with the written consent of the authority in accordance with regulations 16 and 17, or of the Secretary of State in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.

Application to trees to be planted pursuant to a condition

4. In relation to any tree identified in the first column of the Schedule by the letter "C", being a tree to be planted pursuant to a condition imposed under paragraph (a) of section 197 (planning permission to include appropriate provision for preservation and planting of trees), this Order takes effect as from the time when the tree is planted.
