1. EXCLUSION OF PUBLIC

RESOLVED to exclude the public from the meeting during consideration of item *2 below on the grounds contained in paragraphs 1 and 3 of Part 1 of Schedule 12(A) of the Local Government Act 1972.

***2. APPLICATION FOR GRANT OF A 3 MONTH PRIVATE HIRE DRIVERS' LICENCE: CASE NUMBER 12/02063/PHD3 (PARAGRAPHS 1 AND 3)**

(The applicant attended the meeting for this item. He confirmed that he had been informed of his right to be legally represented at the meeting but had chosen not to be. He produced his DVLA licence for inspection by the committee).

In reply to a question, the applicant said that the incident which occurred on the 23 July 2009 took place on the A11, when he was driving a van at 70mph which was not permitted to travel faster than 60mph. He confirmed that it was at approximately 11am and weather conditions were fine.

He then said that the incident which occurred on the 26 June 2012 took place at approximately 12pm and weather conditions were very good.

(The applicant left the meeting at this point).

Following discussion it was:-

RESOLVED to grant a 3 month private hire driver's licence in respect of this application.

3. APPLICATION FOR LICENCE TO PLACE TABLES AND CHAIRS ON THE HIGHWAY – PATISSERIE VALERIE, 12-14 DAVEY PLACE, NORWICH NR2 1PQ

(The applicant attended the meeting for this item).

The council's legal advisor presented the head of citywide services report and answered members' questions. The applicant then commented on the background to the application and responded to members' questions.

Following discussion it was:-

RESOLVED, to approve the application for the grant of a licence to place tables and chairs on the highway as indicated on the plan attached at Appendix B of the Report submitted in respect of Patisserie Valerie, 12-14 Davey Place, Norwich, NR1 1PQ, subject to the council's standard conditions for tables and chairs licences and the following additional conditions as agreed with the applicant:

1. Monday to Sunday use between 10am and 5pm.
2. Temporary barriers with tapping rails to be in situ at all times the pavement seating area is in use.
3. All furniture will be removed from the pavement seating area when not in use.
4. The maximum width of the pavement seating area is to be 1500mm from the front of the premises.
5. A maximum of 4 tables and 10 chairs to be allowed in the pavement seating area.

The applicant was informed of the decision minuted above.
