Report

Background

1. This is one of a series of reports that have been produced regularly since 2008. Their purpose is to ensure members are aware of decisions made under delegated powers, provide information about the overall performance of the service and about the outcome of planning appeals.
2. This report is in relation to the appeals aspect of the planning service. Appendix 1a provides details of appeals lodged which are pending.
3. It can be seen from Appendix 1a that there are four planning appeals pending or awaiting decision. All four of these appeals were delegated officer decisions where the application was refused.
4. There were five appeals dismissed during this quarter. One of these appeals, 94 Appleyard Crescent, was a householder appeal. Three were Delegated Officer Decisions which were refused. One appeal is a Committee decision where members decided to refuse the application. This case relates to the proposed telecommunication mast opposite 161B Bowers Avenue.
5. Since the 30th June, the appeal against the refusal of planning permission at 2 South Park Avenue has also been dismissed. Although there were no appeals allowed during this quarter, the appeal against condition 2 of the planning permission for Blackberry Court, Sweet Briar Road was upheld on the 4th July 2012. This case was somewhat unusual as it related to the reserved matters attached to an application relating to a unit on the retail park. The applicant had not submitted an Arboricultural Impact Assessment (AIA) despite being requested to do so and it being required under our validation checklist. As part of the appeal one was submitted and was considered acceptable by officers. An additional reason for refusal relating to cycle parking was capable of being dealt with by condition. The Inspector upheld the appeal and as part of its submissions the Council applied for costs against the appellant because it regarded the appeal to have been unnecessary.
6. The Inspector concluded that "it appears to me very likely that it (the Council) would have approved the reserved matters application had the assessment been submitted at the application stage. On this basis the appeal would have been avoided. I conclude that Eskmuir Properties acted unreasonably in relying on new evidence it did not submit at the planning application stage and that thus the Council's costs in responding to the appeal were unnecessarily incurred. An award of costs against Eskmuir Properties is thus justified."
