The Committee noted the representations from interested parties. No objectors were present. The Committee noted that the applicant had agreed to amend her operating schedule following discussions with the police and the councils pollution and enforcement section as responsible authorities. The amendments were as follows;

A minimum of two SIA door supervisors will be on the premises from 21.00hrs until close every Friday and Saturday night, also on Sundays before Bank Holidays and Maundy Thursday. In addition to this there will also be one member of staff on each floor when the whole of the premises are being used

The other nights of the week there will be a minimum of one SIA supervisor from 21.00hrs until close on any night when the premises remain open after midnight.

There will be a "last entry" time of 03.30hrs and the premises will open until 04.30hrs. No alcohol will be sold after 04.00hrs.

Alcoholic drinks will not be promoted in any way so as to encourage drinking to excess for example "no happy hour or buy one get one free" offers.
There will be a written procedure on the storage of drugs and fake ID's seized by door supervisors.

The premises will join any city radio link schemes available.

A search policy will be in place.

Amplified live music will be restricted to the cellar floor unless controlled through the in house amplification and speaker system only.

Music and other amplified sound will be inaudible at 10 metres from the nearest noise sensitive dwelling.

The committee also noted that, with the exception of live music, the applicant agreed to amend her application so that regulated entertainment would finish at 04:00.

Determination:

The opening hours are 11.00hrs-04.30hrs

The permitted hours for:

live music are 12:00 – 01:00

recorded music are 11:00 – 04:00

performances of dance, the provision of facilities for dancing and anything of a similar description to live music, recorded music or performances of dance are 12.00hrs-04.00hrs.

The sale by retail of alcohol are 11.00 - 04.00hrs.

The exhibition of films (indoors only) is added between the hours of 11.00hrs-04.00hrs.

The Committee's decision: The variations to the licence were all as a result of the applicants amendments to their operating schedule.

The Committee's reasons:

The Committee felt that the amended application promoted the Licensing Objectives.
