## **REGULATORY COMMITTEE**

1. APPLICATION FOR LICENCE TO PLACE TABLES AND CHAIRS ON THE HIGHWAY – REVOLUTION, 6 QUEEN STREET, NORWICH, NR2 4TL

(The applicant, a member of the public and Councillor Offord attended the meeting for this item).

The licensing manager presented the report and the applicant commented on the background to the application. A plan showing the location of licensed premises in the vicinity was circulated at the meeting.

A member of the public and Councillor Offord (ward councillor for Thorpe Hamlet Ward) addressed the committee outlining their objections to the application.

(The applicant, member of the public, and Councillor Offord left the meeting at this point).

Following discussion it was:-

**RESOLVED**, with 3 members voting in favour (Councillors Driver, Lay and Jeraj) and 1 member voting against (Councillor Ramsay), to approve the application to place tables and chairs on the highway submitted in respect of Revolution, 6 Queen Street subject to:-

- (1) the standard conditions;
- no more than 6 tables and 18 chairs being permitted within the licensed area. Monday to Sunday between 10.30 and 24.00 hours;
- (3) no drinks are to be permitted within the licensed after 22.00 hours;
- (4) the barriers being permitted within the licensed area to remain in place between 10.30 and 02.00 hours.

(The applicant, member of the public, and Councillor Offord were re-admitted to the meeting and informed of the decision minuted above before leaving the meeting.)

## 2. APPLICATION FOR LICENCE TO PLACE TABLES AND CHAIRS ON THE HIGHWAY – CALEYS OF NORWICH LTD, 23 WHITE LION STREET, NORWICH, NR2 1PX

(The applicant attended the meeting for this item).

The licensing manager presented the report and the applicant commented on the background to the application.

The applicant said that he was prepared to compromise on the width of the licensed area and to reduce the application to 3 tables and 6 chairs.

(The applicant left the meeting at this point).

Following discussion it was:-

**RESOLVED** to approve the application to place tables and chairs on the highway submitted in respect of Caley's of Norwich Ltd, 23 White Lion Street subject to:-

- (1) the standard conditions;
- no more than 3 tables and 6 chairs being permitted within the licensed area. Monday to Sunday between 10.00 and 17.00 hours;
- (3) the barriers must not extend over the gulley.

(The applicant was re-admitted to the meeting and informed of the decision minuted above. The applicant then left the meeting.)

## 3. EXCLUSION OF PUBLIC

**RESOLVED** to exclude the public from the meeting during consideration of Items 4 and 5 below on the grounds contained in paragraphs 1 and 3 of Part 1 of Schedule 12(A) of the Local Government Act 1972.

## \*5. SUSPENSION/REVOCATION OF NORWICH CITY COUNCIL DRIVERS LICENCE - CASE NO. 16/31/3/740 (PARAGRAPHS 1 AND 3)

(The licence holder attended the meeting for this item. He confirmed that he had been informed of his right to be legally represented at the meeting but had chosen not to be. He produced his DVLA licence for inspection by the committee).

The licensing manager presented the report. In reply to a question the applicant said that he had not received any further convictions or formal cautions and was not aware of any pending prosecutions since his conviction. He then answered detailed questions about the circumstances of conviction on 27 October 2010 for driving without due care and attention and failing to stop after an accident.

(The applicant left the meeting at this point).

Following a discussion it was -

**RESOLVED**, to take no action.

(The applicant was admitted to the meeting and informed of the decision minuted above. The Chair advised that the committee had the power to revoke, suspend or refuse to renew the licence in the future if his conduct was not up to the standard expected of a licence holder).
