**Purpose** – The Executive is being asked to consider an action plan to implement the recommendations of the Monitoring Officer and Mr P Watson following the investigations into Greyhound Opening/Goldsmith Street Sheltered Housing Scheme.

#### 6. Environmental Strategy – Invest to Save Proposal

(Report of the Director of Transformation)

**Purpose -** To seek Executive approval to earmark £200,000 from the City Council's "invest to save" funding pot, for use to submit as a commitment to the national Local Authority Carbon Management programme (LACM). This commitment will be used to secure an additional £200,000 LACM matchfunding to spend on a range of environmental projects. It is envisaged that the projects will both:

- Help reduce the City Council's carbon footprint, to meet its stated policy of reducing by 6% per year for the next 5 years, and
- Reduce the City Council's energy costs, enabling the investment to be paid back over time.

This request would normally be submitted as part of the Council's annual budget process, but needs to be considered early in order to comply with the LACM bidding timetables.
