Purpose – to remind members of the committee's decision in May 2011 to consult on the Making Room at St Stephens scheme which makes Chapelfield North two-way for buses, delivery vehicles and local access for private vehicles and explains how the scheme can now be delivered in conjunction with the Better Bus Bid funded projects in Grapes Hill and St Stephens Street.
