1. Public questions/ petitions

There were no public questions or petitions received.

2. Declarations of interest

There were no declarations of interest.

3. Minutes

The minutes from 6 June 2019 were attached to the agenda in error and the minutes from 5 September 2019 were circulated at the meeting.

RESOLVED to approve the accuracy of the minutes of the meeting held on 5 September 2019.

4. Amendment to standard conditions for licences to drive hackney carriage and private hire vehicles

The public protection manager presented the report. Members discussed the suggested amendment to the wording of condition 12 contained in the report and following discussion the following wording was agreed:

12. <u>Cautions, Convictions and Barred Lists</u>

The driver shall within seven days of being notified of any caution or conviction or other penalty imposed on them during the period of their licence inform the licensing department of the Council in writing with details of the caution or conviction or other penalty. This includes all motoring offences and driving licence endorsements. The driver shall also inform the licensing department of the Council in writing of inclusion in any list barring or restricting the driver from working with adults or children within seven days of notification, with details of the bar or restriction. The driver must ensure that their notification has been received by the licensing department of the Council.

Members also noted on page four of the green book, agenda page 18, under the first set of bullet points, the last bullet point listed protected characteristics and that this should include pregnancy and maternity and marriage and civil partnership.

It was further noted on the page of contents that The Town Police Clauses Act was 1847 and not 1947.

RESOLVED to:

- (1) amend condition 12 of the 'The Green Book' as above;
- (2) expand the list of protected characteristic listed on page 4 to include pregnancy and maternity and marriage and civil partnership; and
- (3) correct the year of The Town Police Clauses Act to 1847.

5. Statement of Licensing Policy for Sex Establishments

The public protection manager presented the report. It was noted that a number of amendments to the Statement of Licensing Policy for Sex Establishments had been circulated to members since the agenda was published. This was on the advice of the monitoring officer in order that the policy should take account of the Equality Act 2010 legislation.

Members discussed how it would work if an applicant in an area where a cap was set wanted to renew their application. The public protection manager advised that if there were three licences in an area where the policy proposed there should be two the aim would be to defer hearing that application until all three could be heard together. In response to a member question he confirmed that there would be no presumption that an application would be refused if the number of establishments in an area were already at the maximum the policy referenced. He emphasized that whilst a cap on establishments could be set that each application would be heard on its own merits and it was entirely possible that this resulted in a higher number of establishments in an area than the policy had determined was desirable.

Members discussed establishments in the Price of Wales Road area and how applications within this area would be processed. Councillor Price proposed that any applications received from within this area should be deferred and determined on the same day. The public protection manager advised the authority could be open to challenge if a new application was received and any applicant made to wait for their application to be determined. Members discussed the proposal, the idea was put to the vote and fell with three voting in favour and nine against.

Members discussed the inspection regime for establishments and the wording within the policy which referred to how often inspections would be conducted. The public protection manager advised there was no particular regime in place for inspecting establishments, inspections tended to take place on an ad hoc basis and in conjunction with the police. Notice was not always provided to establishments, if licensing officers were attending with the police who were conducting a particular operation then notification may have been provided to establishments. The environmental health and public protection manager said that the basis for inspections was intelligence led rather than there being a set program.

Members were concerned to ensure that inspections occurred as they considered sex establishments could present a risk to employees in terms of exploitation.

RESOLVED to amend the statement of Licensing Policy for Sex Establishments as follows:

- (1) at the top of report page 10, agenda page 54, to add a bullet point to the list, after Human Rights Act 1998, the Equality Act 2010;
- (2) to add an extra paragraph at report page 10, agenda page 54, before the paragraph starting "Paragraph 12", as follows:

"In taking licensing decisions the Authority will be mindful of the public sector equality duty under the Equality Act 2010. Decisions will be taken with due regard to the need to:

Eliminate unlawful discrimination, harassment, victimisation and other conduct prohibited by or under the Equality Act 2010.

Advance equality of opportunity between people who share a protected characteristic and those who do not.

Foster good relations between people who share a protected characteristic and those who do not."

(3) at the bottom of page 5 of the report, agenda page 49, to amend the last paragraph as follows:

"In recognising that different parts of the City have different characteristics the Authority has decided that certain areas as follows are or are not an appropriate location for a sex establishment or for more than a limited number of sex establishments but will nevertheless consider each application upon its individual merits."

(4) at report page 10, agenda page 54, to amend the last paragraph as follows:

"In cases where objections have been received; or if there are concerns regarding the characteristics of the locality; or any other discretionary ground of refusal exists, including that if the application were granted then any maximum number of premises in a relevant locality would be exceeded (as detailed in section 4 of this policy), then the application will be referred to the Licensing Committee for a hearing and determination of the application."

(5) at report page 13, agenda page 57, to amend the last paragraph as follows:

"The Authority will adopt an intelligence led and risk based approach to it's monitoring and inspection regime. In general this will involve carrying out inspections of premises normally once a year unless exceptional circumstances require otherwise. The Authority also reserves the right to conduct random spot checks from time to time as it sees fit."

6. Gambling policy: inclusion of a "No Casino" resolution

The environmental health and public protection manager presented the report. Since the last Gambling Policy was approved by Norwich City Council the law changed and Norwich City Council legally could not issue a licence for a large casino within its area. Therefore the "No Casino" resolution within the current policy was defunct.

Members discussed officer's recommendation to remove the "no casinos" resolution from the Gambling Policy and whilst acknowledging the change in legislation, there was still a desire to show a commitment to no casinos in the area and a desire therefore to keep the resolution.

RESOLVED to acknowledge the legal position as regards the inability of the authority to grant a casino licence but to maintain a "no casino" resolution within the Gambling Policy.

7. Gambling policy: updated local area profile

The environmental health and public protection manager presented the report. Members expressed disappointment that the report did not include a Gambling Statement of Principles and noted that this outstanding piece of work was overdue. Members considered that the updated local area profile was not adequately updated, the data was out of date and more recent data sets were available and should be used.

The environmental health and public protection manager apologised to members of the committee that the data was not up to date and agreed to amend the local area profile and return with it and the Gambling Statement of Principles to the March 2020 meeting of licensing Committee.

The environmental health and public protection manager displayed the new interactive map tool. In response to a member question he advised the tool currently did not list live music venues but it was possible to add new criteria. A member noted that the information contained in the report at pages 115-152 was incorrect and incomplete and the information on page 116 under the heading services for people in financial difficulties included pawnbrokers and cash convertors along with foodbanks which were not what members considered to be services which benefited individuals in financial difficulty. Another member noted that on page 117 under the heading homelessness services these were a list of services which were not solely for homeless individuals. A member also questioned why medical centres were listed as treatment centres as this had a different meaning. It was agreed that the links would be sent to members of the committee and an opportunity provided for feedback.

RESOLVED to ask the environmental health and public protection manager to:

(1) present an updated and a finalised Gambling Statement of Principles and local area prolife to the next meeting of licensing committee in March 2020; and

(2) send the links to the intertactive mapping tool to members of the committee to review the tool.

8. Standing item – Regulatory subcommittee minutes

It was noted that Councillor Stutely was present at the meeting of 10 June 2019 (pm) and was the chair of the meeting.

Report

Background

- 1. The Council is the licensing authority for the purposes of the Gambling Act 2005, which requires the Council to prepare a Gambling Statement of Principles that it proposes to apply in exercising its functions under the Act.
- 2. The Statement of Principles sets out the general approach the Council will take when carrying out its regulatory role under the Act and promoting the three licensing objectives:
 - preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime
 - ensuring that gambling is conducted in a fair and open way
 - protecting children and other vulnerable persons from being harmed or exploited by gambling.
- 3. The Act specifies that Local Authorities should "aim to permit" gambling, provided it is in accordance with the Code of Practice and guidance issued by the Gambling Commission, reasonably consistent with the licensing objectives and in accordance with the Statement of Principles. The effect of this duty is that Licensing Authorities must approach their functions in a way that seeks to regulate gambling by using their powers to promote the licensing objectives rather than by starting out to prevent it altogether.
- 4. The current Statement was adopted by the council in November 2006, and published in January 2007.
- 5. At the 6 June 2019 meeting of licensing committee members considered a report detailing the responses received from the statutory public consultation on a draft of an updated Statement of Principles and resolved to make a number of amendments to the draft document. Details of the resolutions of that meeting are attached at Appendix A.
- 6. Following further consultation with the chair and vice-chair of the Licensing Committee to clarify matters with regard to imposing standard conditions, and also discussion at Licensing Committee on the 30 January 2020, where members decided to include a 'no casinos' resolution, the amended draft Gambling Statement of Principles is attached at Appendix B.
- 7. Each part resolution detailed in Appendix A includes a reference to the paragraph number where the resolution has been addressed in the draft document.
- 8. This draft Statement of Principles does not include a Local Area Profile which is produced as a standalone document and will be the subject of a separate report.

Legal Implications

9. Section 349(1) of the Gambling Act 2005 requires the Council, as licensing authority, to prepare and publish a statement of principles to cover each successive period of three years. Section 349(2) requires the Council to review the statement from time to

time, revise the statement if thought necessary as a result of the review and publish the revision before giving effect to it.

- 10. Before a statement or revision comes into effect, the regulations require licensing authorities to publish a notice of their intention to publish a statement or revision. The notice must:
 - specify the date on which the statement or revision is to be published
 - specify the date on which the statement or revision will come into effect
 - specify the internet address where the statement or revision will be published and the address of the premises at which it may be inspected
 - be published on the authority's website and in/on one or more of the following places for at least four weeks before it comes into effect:
 - a local newspaper circulating in the area covered by the statement
 - a local newsletter, circular, or similar document circulating in the area covered by the statement
 - a public notice board in or near the principal office of the authority
 - a public notice board on the premises of public libraries in the area covered by the statement.

If members resolve that the revised draft Statement of Principles be presented for adoption at Council, the above public notification requirements will take place once approved by Council.

Conclusion

- 11. The Act requires the Council to review its Gambling Statement of Principles every 3 years and requires that we consult on the proposed statement of principles. A review of the Statement has been completed, a draft prepared and opened to public consultation, and appropriate amendments have been proposed following the consultation.
- 12. Members are asked to consider recommending that the draft Gambling Statement of Principles be adopted at Council.

c) Add a condition to new gambling licenses to state that the licencee must keep a register (known as a refusals book) to include details of self excluded customers, the time, date and description of underage persons entering the premises and the name of the salesperson who verified this, with the book being kept on the premises for inspection by the licensing authority and the police.

d) Add a condition that within betting premises, adult gaming centres and bingo venues, signage should be displayed with contact details of support organisations such as Gamcare, the Samaritans and Citizens Advice.

- Included at para. 9.18(3)

e) Include within the Local Area Profile definitions of the thresholds for identifying high spend and high time gamblers as well as the definition of children in poverty within the context of the profile.

f) Within section A, add an acknowledgment that the suitability of locations for gambling premises should also take into account low level crime and anti-social behaviour and not just organised crime.

- Para. 9.10(A) amended

g) Within section A, expand the mention of CCTV to include 'this may include defining the type and quality of the CCTV, the duration of retention of images and ensuring that these are made available to the police and the licensing authority for inspection.'

- Included at para. 9.18(7)

- 3. Ask the licensing and markets manager to bring a report to a future licensing committee on a 'no casino' resolution.
 - 'No casinos' resolution from meeting on 30 January 2020 included at para. 12.1

Part A - General

1. The Gambling Licensing Objectives

- 1.1 In exercising most of its functions under the Gambling Act, 2005 ("the Act"), Licensing Authorities must have regard to the licensing objectives set out in section 1 of the Act. The three licensing objectives are:-
 - Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime;
 - Ensuring that gambling is carried out in a fair and open way
 - Protecting children and other vulnerable persons from being harmed or exploited by gambling.

It is noted that the Gambling Commission has stated: "The requirement in relation to children is explicitly to protect them from being harmed or exploited by gambling".

The City Council as Licensing Authority takes these objectives seriously and is committed to protecting **all** vulnerable people of whatever age from being harmed or exploited by gambling.

- 1.2 This Licensing Authority is aware that, in accordance with Section 153 of the Act, in making decisions about premises licences and temporary use notices it should aim to permit the use of premises for gambling in so far as it thinks it is:
 - in accordance with any relevant code of practice issued by the Commission
 - in accordance with any relevant guidance issued by the Commission
 - reasonably consistent with the licensing objectives and
 - in accordance with the Authority's statement of licensing policy

.

1.3 In matters of regulation under the Gambling Act 2005 (the "Act") Norwich City Council as Licensing Authority recognises it is subject to the Regulators' Code. That code imposes a number of obligations on the Authority, including one that it should carry out its activities in a way that it supports those it regulates to comply and grow. Additionally under the Code, when designing and reviewing policies, the Authority must among other things understand and minimise the negative economic impact of its regulatory activities and regulate and minimise the costs of compliance of those it regulates. The Authority also recognises that under the Code it should take an evidenceining of those \ hoursestimates based approach in determining priority risks and recognise the compliance record of those it regulates.

2. Introduction

- 2.1 Licensing authorities are required by the Act to publish a statement of the principles which it proposes to apply when exercising its functions. This statement must be published at least every three years. The statement must also be reviewed from "time to time" and any amended parts re-consulted upon. Following any amendment and consultation, the revised statement will then be re-published.
- 2.2 Norwich City Council as Licensing Authority (referred to in this document as "This Licensing Authority") published its first Statement of Principles (generally referred to as the Councils Gambling Policy) in December 2006 following statutory consultation. The Gambling Policy has been published every three years since.
- 2.3 In preparing this (2019) version of the Statement of Principles (Gambling Policy) this Licensing Authority has undertaken a significant revision and amendment to take account of various issues . In recent particular recent changes brought about by the Commission, changes to the law and updated current practices.
- 2.4 The Gambling Commission ("the Commission") has introduced new provisions in its social responsibility code within the Licence Conditions and Codes of Practice (LCCP), which require gambling operators to assess the local risks to the licensing objectives posed by the provision of gambling facilities at each of their premises, and to have policies, procedures and control measures to mitigate those risks. This change in national policy is intended to provide a well evidenced and transparent approach to considering and implementing measures to address the risks associated with gambling.

The risk assessment will be premises specific and highlight factors relevant and related to the local area (ward) in which the premises are situated or proposed.

- 2.5 The introduction of new provisions in the social responsibility code within the LCCP encourages local authorities, the Commission and the industry to work in partnership to address local issues and concerns. This movement towards increased partnership working is something that Norfolk authorities have been doing for a number of years. We have found that a risk-based approach to regulation enables the authority to prioritise resources where they are most needed and can be most effective.
- 2.6 The risk based approach provides a better understanding of, and enables a proportionate response, to risk. This approach includes looking at future risks and thinking about risks in a probabilistic way. Risk is not necessarily related to an event that has happened. Risk is related to the probability of an event happening and the likely impact of that event. In this case it is the risk of the impact on the licensing objectives.
- 2.7 This licensing authority is working with other licensing authorities across Norfolk to develop guidance to assist gambling operators in undertaking and preparing their local (premises) risk assessments. This guidance (to be published as a separate document) will provide a framework for the local risk assessment process that will provide a uniform approach across all non-remote gambling sectors. This will benefit the Council as Licensing Authority under the Act, as well as responsible authorities and interested parties when considering new and variation applications. The local risk assessments will also enable this licensing authority to establish a more progressive compliance inspection regime.
- 2.8 Gambling operators are required to undertake a risk assessment for all of their existing premises in April 2016. Following that date

> operators must also undertake a review of those assessments when certain triggers are met. These triggers, along with this licensing authority's views on what would instigate either a new assessment or the review of an existing one will be detailed within the guidance document.

- 2.9 This licensing authority considers that these local risk assessments are a key component of the overall assessment and management of the local risks. This authority will assist operators in this process by providing specific information on its concerns surrounding gambling within the City and the impact that premises can have on the licensing objectives. This will be contained within the Statement of Licensing Principles (Gambling Policy) as detailed below.
- 2.10 This local risk assessment process is not the same as other forms of risk assessment undertaken by gambling operators, such as Health and Safety at Work, Fire Safety and Food Hygiene, etc. These local risk assessments are specific to the potential harm that gambling premises can have on one or more of the licensing objectives under the Act. They are specific to the premises, the local area and the local community.

Consultation process on the Statement of Principles (Gambling Policy)

- 2.11 The Gambling Act requires that the following parties are consulted by Licensing Authorities:
 - The Chief Officer of Police;
 - One or more persons who appear to the authority to represent the interests of persons carrying on gambling businesses in the authority's area;
 - One of more persons who appear to the authority to represent the interests of persons who are likely to be affected by the

exercise of the authority's functions under the Gambling Act 2005.

- 2.13 Further consultation with these bodies has been undertaken on this updated 2019 version of the statement of principles (Gambling Policy) prior to an updated statement being adopted.
- 2.14 It should be noted that this statement of principles will not override the right of any person to make an application, make representations about an application or apply for the review of a licence as each will be considered on its own merits and according to the statutory requirements of the Gambling Act 2005.

Local Area profile

- 2.15 A detailed local area profile has been prepared based on local knowledge and taking into account a wide range of factors, data and information held by the licensing authority and its partners. It is anticipated that the local area profile will give operators a better awareness of the local area and the risks, which includes both potential and actual risks. The local area profile document can be accessed via the council's website.
- 2.16 In summary the area is as follows:

Norwich City Council is situated in the County of Norfolk, which contains 7 District Councils in total. The City Council area has a population of 141,000 (2016 midyear estimate) making it the third largest in the County in terms of population. In terms of area it is the smallest, covering 15 square miles. The Council area is entirely urban. This is shown in the map attached.

3. Declaration

- 3.1 In producing this Statement of Principles (Gambling Policy) this Licensing Authority declares that it has had regard to
 - the licensing objectives of the Gambling Act 2005,
 - the guidance issued by the Commission to licensing authorities (5th edition September 2015 with Parts 17, 18 & 19 updated September 2016) referred to in this document as "Commission's Guidance" and
 - any responses from those consulted on the Statement of Principles (Gambling Policy).

4. Responsible Authorities

- 4.1 The Licensing Authority is required by regulations to state the principles it will apply in exercising its powers under Section 157(h) of the Act to designate, in writing, a body which is competent to advise the authority about the protection of children from harm. The principles are
 - The need for the body to be responsible for an area covering the whole of the Licensing Authority's area
 - The need for the body to be answerable to democratically elected persons rather than any particular vested interest group.

In accordance with the Commission's Guidance, this Authority designates the Norfolk Safeguarding Children's Board for this purpose.

.2 The contact details of all the Responsible Authorities under the Act for this licensing authority area are attached at Appendix 1



5. Interested parties

5.1 Interested parties can make representations about licence applications, or apply for a review of an existing licence. These parties are defined in the Act as persons who:

- a) live sufficiently close to the premises to be likely to be affected by the authorised activities,
- b) have business interests that might be affected by the authorised activities, or
- c) represent persons who satisfy paragraph (a) or (b)
- 5.2 This Licensing Authority is required by regulations to state the principles it will apply in exercising its powers under the Act to determine whether a person is an interested party. The principles are:
 - Each case will be decided upon its merits.
 - This authority will not apply a rigid rule in making its decision; however, it will consider the examples provided in part 8 of the Commission's Guidance. (reproduced in figure 2 below) The authority will also consider the Commission's Guidance that "has business interests" should be given the widest possible interpretation and include partnerships, charities, faith groups and medical practices.

.....



8.14 It could be argued that any gambling business could be affected by another gambling business expanding into any part of Great Britain. But that is unlikely to be enough to satisfy the test of being 'a person with business interests that might be affected by the premises' under consideration.

For example, an operator in a particular sector be it casino, bingo, betting etc, should not be able to lodge representations on every application put in by a rival operator anywhere in the country, simply because they are in competition within the same gambling sector. Specifically, licensing authorities are reminded that the 'demand test' from previous gambling legislation does not apply under the Act.

8.15 The licensing authority should be satisfied that the relevant business is likely to be affected. Factors that are likely to be relevant include:

- the size of the premises
- the 'catchment' area of the premises, that is, how far people travel to visit the premises
- whether the person making the representation has business interests in that catchment area that might be affected.
- People representing those in the above categories

8.16 Interested parties can be people who are democratically elected such as councillors and MPs, as persons representing individuals in the other categories. This would include county, parish and town councillors. Other representatives might include bodies such as trade associations and trade unions, and residents' and tenants' associations. A school head or governor might act in representing the interests of pupils or parents and a community group might represent vulnerable people living near to the proposed premises.

8.17 Save for democratically elected persons, licensing authorities should satisfy themselves on a case by case basis that a person does represent interested parties, and request written evidence where necessary. A letter from the interested person(s) they are representing would be sufficient.

- 5.3 Interested parties can be persons who are democratically elected such as councillors and MP's. No specific evidence of being asked to represent an interested person will be required as long as the Councillor / MP represents the ward likely to be affected. Other than these however, the Authority will generally require written evidence that a person/body (for example an advocate or relative) 'represents' someone who either lives sufficiently close to the premises to be likely to be affected by the authorised activities and/or has business interests that might be affected by the authorised activities. A letter from one of these persons, requesting the representation is sufficient.
- 5.4 If individuals wish to approach councillors to ask them to represent their views then care should be taken that the councillors are not part of the Licensing sub-committee dealing with the licence application. If there are any doubts then please contact the Authority's licensing team (contact details, page 58.

6. Information exchange

- 6.1 In fulfilling its functions and obligations under section 29 (Licensing Authorities providing information to the Commission), section 30 (the provision of information by the Commission) and section 350 (exchange of information may be subject to conditions) of the Act the Licensing Authority may exchange relevant information with other regulatory bodies. In exchanging such information, the Licensing Authority will conform to the requirements of data protection and freedom of information legislation in accordance with the Council's existing policies.
- 6.2 The Licensing Authority will also have regard to any Guidance issued by the Commission on this matter, as well as any relevant regulations issued by the Secretary of State under the powers provided in the Act.

6.3 Details of those persons making representations will be made available to applicants to allow for negotiation and, in the event of a hearing being held, will form part of a public document. Anyone making representations or applying for the review of a premises licence will be informed that their details will be disclosed.

6.4 In seeking to achieve its aim to safeguard all vulnerable persons of whatever age, the City Council as Licensing Authority will work with the Norfolk Safeguarding Adults Board and seek input where appropriate from Norfolk County Council Adult services and the Norfolk and Suffolk NHS Foundation Trust in respect of mental health services. Such agencies are not responsible authorities as defined in the Act, but this Licensing Authority will consider valid representations from such agencies if they are made as Interested parties representing local residents or businesses.

7. Enforcement

- 7.1 Licensing authorities are required by regulation under the Act to state the principles to be applied by the authority in exercising the functions under Part 15 of the Act with respect to the inspection of premises; and the powers under section 346 of the Act to institute criminal proceedings in respect of the offences specified.
- 7.2 This Licensing Authority's **principles** are that it will be guided by the Commission's Guidance and will endeavour to be:
 - **Proportionate**: regulators should only intervene when necessary: remedies should be appropriate to the risk posed, and costs identified and minimised;
 - **Accountable**: regulators must be able to justify decisions, and be subject to public scrutiny;
 - **Consistent**: rules and standards must be joined up and implemented fairly;

.....

- **Transparent**: regulators should be open, and keep regulations simple and user friendly; and
- **Targeted**: regulation should be focused on the problem, and minimise side effects.
- 7.3 In accordance with the Commission's Guidance this Licensing Authority will endeavour to avoid duplication with other regulatory regimes as far as possible.
- 7.4 This Licensing Authority's main enforcement and compliance role in terms of the Act will be to ensure compliance with the premises licences and other permissions that it authorises. The Commission is the enforcement body for Operating and Personal Licences. Concerns about manufacture, supply or repair of gaming machines will not be dealt with by the Licensing Authority but should be notified to the Commission.
- 7.5 The Councils enforcement policy will be followed in respect of any compliance monitoring and enforcement action taken in concerning gambling activities under the licensing authority's enforcement jurisdiction. This is accessible via the council's website.
- 7.6 <u>Enforcement inspections-</u>This licensing authority has adopted and implemented a risk-based enforcement approach to inspections, based on;

The licensing objectives

Relevant codes of practice

- Guidance issued by the Commission, in particular at Part 36
- The principles set out in this statement of licensing policy
- 7.7 As well as sanctions available under the Act this licensing authority will seek to use all appropriate powers available to it.

7.8 Where there is a Primary Authority scheme in place, this licensing authority will seek guidance from the Primary Authority before taking any enforcement action. The current Primary Authorities are detailed on the Gambling Commission website as per the following link

- 7.9 This licensing authority will work together with the Commission to identify and investigate organised or persistent illegal activity.
- 7.10 Fees for certain gambling permits and licensing transactions are set nationally by statute. They include
 - Unlicensed Family Entertainment Centre Gaming Machine Permits
 - Registration of Small Society Lottery (including an annual maintenance fee)
 - Club Gaming Permits
 - Club Gaming Machine Permits
 - Alcohol Licensed Premises Gaming Machine Permits
 - Prize Gaming Permit

However, fees for licences issued under the Act by this licensing authority are set by this licensing authority in accordance with statutory provisions. This licensing authority has sought to set fees at a level to cover the costs of undertaking the administration of the gambling licensing function. Fees are approved each year by the Full Council and are published on the Councils website

.....

8. Licensing Authority functions

Licensing Authorities are required under the Act to:

- Be responsible for the licensing of premises where gambling activities are to take place by issuing Premises Licences
- Issue Provisional Statements
- Regulate members' clubs and miners' welfare institutes who wish to undertake certain gaming activities by issuing Club Gaming Permits and/or Club Machine Permits
- Issue Club Machine Permits to Commercial Clubs
- Grant permits for the use of certain lower stake gaming
 machines at unlicensed Family Entertainment Centres
- Receive notifications from alcohol licensed premises (under the Licensing Act 2003) for the use of two or fewer gaming machines
- Issue Licensed Premises Gaming Machine Permits for premises licensed to sell/supply alcohol for consumption on the licensed premises, under the Licensing Act 2003, where there are more than two machines
- Register small society lotteries below prescribed thresholds Issue Prize Gaming Permits

Receive and Endorse Temporary Use Notices

Receive Occasional Use Notices

- Provide information to the Commission regarding details of licences issued (see section above on 'information exchange)
- Maintain registers of the permits and licences that are issued under these functions

.....

It should be noted that this Licensing Authority will not be involved in licensing remote gambling at all. This will fall to the Commission via operating licences.

Part B - Premises Licences

9. General Principles

- 9.1 Premises licences will be subject to the requirements set out in the Act and regulations, as well as specific mandatory and default conditions which will be detailed in regulations issued by the Secretary of State. Licensing Authorities are able to exclude default conditions and also attach others, where it is believed to be appropriate.
- 9.2 In accordance with Section 153 of the Act, this Licensing Authority is aware that in making decisions about premises licences it should aim to permit the use of premises for gambling in so far as it thinks it is:
 - in accordance with any relevant code of practice issued by the Commission;
 - in accordance with any relevant guidance issued by the Commission ;
 - reasonably consistent with the licensing objectives; and
 in accordance with the Authority's Statement of Principles (Gambling Policy).
- 9.3 It is appreciated that as per the Commission's Guidance "moral and ethical objections to gambling are not a valid reason to reject applications for premises licences" (except as regards any 'no casino resolution' see section on Casinos below) and also that unmet demand is not a criterion for a licensing authority.¹
- 9.4 *Appropriate Licensing Environment* This licensing authority also notes Commission guidance on this subject (previously known as

¹ UNMET DEMAND - The Licensing Authority should not consider whether there are enough gambling outlets within a given area to fulfil customer's needs, wants and expectations.

primary gambling activity). It is not permissible for an operator to offer gaming machines on a premises which is licensed for non-remote betting but not to offer sufficient facilities for non-remote betting. A non-remote betting operating licence authorises its holder to 'provide facilities for betting' (s.65(2)(c) of the Act). Likewise, a betting premises licence authorises premises to be used for 'the provision of facilities for betting...' (s.150(1)(e) of the Act). The ability to make up to four gaming machines, within categories B2 – D, available is an additional authorisation conferred upon the holder of a betting premises licence (s.172(8) of the Act); it is not a free standing right to make gaming machines available for use. It follows that unless a betting premises operator offers sufficient facilities for betting it should not be making gaming machines available on the premises in question.

- 9.5 This authority notes the Commission's view that it is also important, in relation to the licensing objective of protecting vulnerable persons from being harmed or exploited by gambling, that customers should be offered a balanced mix of betting and gaming machines in licensed betting premises. Accordingly, an operating licence condition provides that gaming machines may be made available for use in licensed betting premises only at times when there are also sufficient facilities for betting available. In this respect, such facilities must include information that enables customers to access details of events on which bets can be made, make such bets, learn of the outcome and collect any winnings.
- 9.3 **Definition of 'premises'** Premises is defined in the Act as 'any place'. Different premises licences cannot apply in respect of a single premise at different times. However, it is possible for a single building to be subject to more than one premises licence, provided they are for different parts of the building and the different parts of the building can be reasonably regarded as being different premises. Whether

> different parts of a building can properly be regarded as being separate premises will always be a question of fact in the circumstances. However, the Commission does not consider that areas of a building that are artificially or temporarily separate can be properly regarded as different premises.

- 9.4 This Licensing Authority takes particular note of the Commission Guidance which states that Licensing Authorities should take particular care in considering applications for multiple licences for a building and those relating to a discrete part of a building used for other (non-gambling) purposes. In particular, entrances and exits from parts of a building covered by one or more licences should be separate and identifiable so that the separation of different premises is not compromised and that people do not 'driff' into a gambling area.
- 9.5 The Licensing Authority will also pay particular attention to applications where access to the licensed premises is through other premises (which themselves may be licensed or unlicensed). Specific issues for consideration would be whether children can gain access; compatibility of the two establishments; and ability to comply with the requirements of the Act. Additionally, an overriding consideration would be whether, taken as a whole, the co-location of the licensed premises with other facilities has the effect of creating an arrangement that would otherwise be prohibited under the Act.

9.6

The Authority appreciates, it is perfectly legitimate for an application to be made for a premises licence even though the premises are not finished. (As an alternative to the applicant making an application for a provisional statement.) In such cases the Authority will require sufficient detail to be submitted with the application to enable an application to be properly considered and determined.

9.7 **Location** - This Licensing Authority is aware that demand issues cannot be considered with regard to the location of premises but that considerations in terms of the licensing objectives can. In accordance with the Commission Guidance, this

Licensing Authority will pay particular attention to the protection of children and vulnerable persons from being harmed or exploited by gambling, as well as issues of crime and disorder. Should any specific policy be decided upon in respect of areas where gambling premises should not be located, this statement will be updated to reflect that. It should be noted that any such policy does not preclude any application being made and each application will be decided on its merits, with the onus on the applicant to show how potential concerns can be overcome

- 9.8 When determining an application to grant a Premises Licence or review a Premises Licence, careful consideration will be taken regarding the proximity of the premises to:
 - a) schools, and other educational establishments
 - b) vulnerable adult centres

e)

- c) residential areas where there may be a high concentration of families with children
 - premises licensed under the Licensing Act 2003
 - premises licensed under the Local Government (Miscellaneous Provisions) Act 1976

The proximity of premises taken into consideration will vary depending on the size and scope of the gambling premises concerned. Each case will, however, be decided on its merits. Therefore, if an applicant can effectively demonstrate how they might overcome licensing objective concerns, this will be taken into account.

- 9.9 **Duplication with other regulatory regimes -** This Licensing Authority will seek to avoid any duplication with other statutory/regulatory systems wherever possible. This Authority will not consider whether a licence application is likely to obtain planning or building regulation consent, in its consideration of it. It will however listen to, and consider carefully, any concerns about conditions which are not able to be met by licensees due to planning restrictions, should such a situation arise.
- 9.10 Licensing objectives Premises licences granted must be reasonably consistent with the licensing objectives. With regard to these objectives, this Licensing Authority has considered the Commission's Guidance and some comments are made below.
- Preventing gambling from being a source of crime or disorder, Α. being associated with crime or disorder or being used to support crime - This Licensing Authority is aware that the Commission will be taking a leading role in preventing gambling from being a source of crime. The Commission's Guidance does however envisage that Licensing Authorities should pay attention to the proposed location of gambling premises in terms of this licensing objective. Thus, where an area has known high levels of crime and anti-social behaviour, this Authority will consider carefully whether gambling premises are suitable to be located there and whether conditions may be suitable such as the provision of door supervisors or CCTV. This Licensing Authority is aware of the distinction between disorder and nuisance and will consider factors such as whether police assistance was required and how threatening the behaviour was to those who could see it, so as to make that distinction.
- B. Ensuring that gambling is conducted in a fair and open way –
 This Licensing Authority has noted that the Commission has stated that it would generally not expect Licensing Authorities to become

> concerned with ensuring that gambling is conducted in a fair and open way, as this will be a matter for either the management of the gambling business (and therefore relevant to the Operating Licence), or will be in relation to the suitability and actions of an individual (and therefore relevant to the Personal Licence). Both of these options fall under the remit of the Commission.

> However, in relation to the licensing of tracks this Licensing Authority's role will be different from other premises in that track operators will not necessarily have an operating licence. Tracks are defined in section 353 of the Act to mean horse-race course, dog track or other premises on any part of which a race or other sporting event takes place or is intended to take place. In these circumstances, the Premises Licence may need to contain certain conditions to ensure that the environment in which betting takes place is suitable and that betting areas are properly administered (see **Tracks** – Page 31).

C. Protecting children and other vulnerable persons from being harmed or exploited by gambling – This Licensing Authority has noted the Commission's Guidance states that this objective means preventing children from taking part in gambling (as well as restriction of advertising so that gambling products are not aimed at or are, particularly attractive to children).

As stated previously, this Licensing Authority when considering this objective, will seek to protect all vulnerable persons whatever their age and take into account advertising accordingly.

This Licensing Authority will therefore consider, as suggested in the Commission Guidance, whether specific measures are required at a particular premises, with regard to his licensing objective. Appropriate measures may include such matters as the supervision of entrances, the segregation of gambling from areas frequented by children and the

.....

supervision of gaming machines in non-adult gambling specific premises.

The Licensing Authority will also make itself aware of any Codes of Practice issued by the Commission concerning this licensing objective in relation to specific premises, such as casinos.

Regarding the term "vulnerable persons" it is noted that the Commission is not seeking to offer a definition but states that "it will for regulatory purposes assume that this group includes people who gamble more than they want to; people who gamble beyond their means; and people who may not be able to make informed or balanced decisions about gambling due to a mental impairment, alcohol or drugs." This Licensing Authority will consider this licensing objective on a case by case basis.

- 9.11 **Conditions** Any conditions attached to licences will be proportionate and will be
 - relevant to the need to make the proposed building suitable as a gambling facility
 - directly related to the premises and the type of licence applied for;

fairly and reasonably related to the scale and type of premises; and

reasonable in all other respects.

9.12 Decisions upon individual conditions will be made on a case by case basis, although there will be a number of control measures this Licensing Authority will consider utilising should there be a perceived need, such as the use of door supervisors, supervision of adult gaming machines and appropriate signage for adult only areas. There

> are specific comments made in this regard under some of the licence types below. This Licensing Authority will also expect the licence applicant to offer his/her own suggestions as to ways in which the licensing objectives can be met effectively – see also paragraphs 9.18 - 9.20.

- 9.13 This Licensing Authority will also consider specific measures which may be required for buildings which are subject to multiple premises licences. Such measures may include the supervision of entrances; segregation of gambling from non-gambling areas frequented by children; and the supervision of gaming machines in non-adult gambling specific premises in order to pursue the licensing objectives. These matters are in accordance with the Commission's Guidance.
- 9.14 This Licensing Authority will also ensure that where category C or above machines are on offer in premises to which children are admitted:
 - all such machines are located in an area of the premises which is separated from the remainder of the premises by a physical barrier which is effective to prevent access other than through a designated entrance;

only adults are admitted to the area where these machines are located;

access to the area where the machines are located is supervised;

the area where these machines are located is arranged so that it can be observed by the staff or the licence holder; and

at the entrance to and inside any such areas there are prominently displayed notices indicating that access to the area is prohibited to persons under 18.

.....

These considerations will apply to premises including buildings where multiple premises licences are applicable.

- 9.16 This Licensing Authority is aware that tracks may be subject to one, or more than one, Premises Licence, provided each licence relates to a specified area of the track. In accordance with the Commission's Guidance, this Licensing Authority will consider the impact upon the third licensing objective and the need to ensure that entrances to each type of premises are distinct and that children are excluded from gambling areas where they are not permitted to enter.
- 9.17 It is noted that there are conditions which the Licensing Authority cannot attach to premises licences. These are:
 - any condition on the premises licence which makes it impossible to comply with an operating licence condition (Operating Licences are issued by the Gambling Commission);
 - conditions relating to gaming machine categories, numbers, or method of operation;
 - conditions which provide that membership of a club or body be required (the Act specifically removes the membership requirement for casino and bingo clubs and this provision prevents it being reinstated); and

conditions in relation to stakes, fees, winning or prizes.

Applicants may offer licence conditions to the licensing authority as a part of their application. The following are examples of such conditions and are likely to be applicable to the majority of premises. If applicants do not consider them appropriate for their premises, then this should be addressed in the application : -

.....

- There shall be a minimum of 2 staff (excluding back room staff) on duty at the premises at all times when it is open, whose duties are to include the age verification of persons entering the premises who appear to be under the age of 21 years.
- 2. "Challenge 21":
 - (a) The Licensee shall have a "Challenge 21" policy whereby all customers who appear to be under the age of 21 are asked for proof of their age.
 - (b) The Licensee shall prominently display notices advising customers of the "Challenge 21" policy.
 - (c) The following proofs of age are the only ones to be accepted:
- Proof of age cards bearing the "Pass" hologram symbol
- UK Photo Driving licence
- Passport

Alternatively, applicants may consider having a "Challenge 25" Policy.

- The Licensee shall ensure that prominent signage shall be displayed in areas accessible to the public, promoting support organisations, such as, but not limited to, GAMSTOP, Gamcare, Samaritans and Citizens Advice.
- 4. The Licensee shall complete a risk assessment assessing the local risks to the licensing objectives posed by the provision of gambling facilities at the premises, and to have policies, procedures and control measures in place to mitigate those risks. The Licensee shall also ensure the following:-
 - (a) All documents produced in compliance with the above shall be reviewed on a regular basis and kept up to date.
 - (b) A copy of all the relevant documents shall kept at the licensed premises and made available for inspection by an

.....

officer of the Licensing Authority, Trading Standards or the Police.

- (c) The Licensee shall ensure that each member of staff has received adequate training on the contents of the relevant documents and that this is properly documented and training records kept. The training records to be kept on the licensed premises and made available for inspection by an officer of the Licensing Authority, Trading Standards or the Police.
- 5. Staff Competence and Training:
 - (a) The Licensee shall keep a written record of all staff authorised to verify the age of customers, the record to contain the full name, home address, date of birth and national insurance number of each person so authorised. The staff record to be kept on the licensed premises and made available for inspection by an officer of the Licensing Authority, Trading Standards or the Police.
 - (b) The Licensee shall ensure that each member of staff authorised to verify the age of customers has received adequate training on the law with regard to under-age gambling and the procedure if an underage person enters the premises, and that this is properly documented and training records kept. The training records to be kept on the licensed premises and made available for inspection by an officer of the Licensing Authority, Trading Standards or the Police.
 - (c) The Licensee shall ensure that each member of staff authorised to verify the age of customers is fully aware of his /her responsibilities in relation to verifying a customer's age and is able to effectively question customers and check evidence of proof of age.

- 6. Refusals Book:
 - (a) The licensee shall keep a register (Refusals Book) to contain details of self-excluded customers as well as the time and date, description of under-age persons entering the premises, and the name/signature of the sales person who verified that the person was under-age.
 - (b) The Refusals book to be examined on a regular basis by the licensee and date and time of each examination to be endorsed in the book.
 - (c) The Refusals Book to be kept on the licensed premises and made available for inspection by an officer of the Licensing Authority, Trading Standards or the Police.
- 7. CCTV:
 - (a) The CCTV system shall be maintained in a good working order and fully operational covering both internal and external areas when the premises are open to the public.
 - (b) The medium on which CCTV images are recorded will be clearly identifiable, stored securely and shall be retained for a period of 31 days and shall be made available for inspection by the Police or an officer of the licensing authority, upon request.
- 9.19 **Door Supervisors** The Commission advises in its Guidance that Licensing Authorities may consider whether there is a need for door supervisors in terms of the licensing objectives of protection of children and vulnerable persons from being harmed or exploited by gambling, and also in terms of preventing premises becoming a source of crime.
- 9.20 Where it is decided that supervision of entrances and/or machines is appropriate for particular cases a consideration of whether these need to be SIA licensed or not will be necessary. It will not be automatically

.....

assumed that they need to be licensed as the statutory requirements for different types of premises vary (as per the Guidance)

It should be noted that there is a specific exemption from SIA registration for those persons directly employed by the operator of a bingo club or casino. Therefore, only third party contract staff are

10. Adult Gaming Centres

10.1 This Licensing Authority will specifically have regard to the need to protect children and vulnerable persons from harm or being exploited by gambling and will expect the applicant to satisfy the authority that there will be sufficient measures to, for example, ensure that under 18 year olds do not participate in adult-only gaming activities at the premises.

This Licensing Authority may consider measures to meet the licensing objectives such as:

- Proof of age schemes
- CCTV
- Supervision of entrances / machine areas
- Physical separation of areas
- Location of entry
- Notices / signage
- Specific opening hours
- Self-exclusion schemes
- Provision of information leaflets / helpline numbers for organisations such as GamCare.

This list is not mandatory, nor exhaustive, and is merely indicative of example measures.

11. (Licensed) Family Entertainment Centres

11.1 This Licensing Authority will specifically have regard to the need to protect children and vulnerable persons from harm or being exploited by gambling and will expect the applicant to satisfy the authority, for example, that there will be sufficient measures to ensure that under 18 year olds do not have access to the adult only gaming machine areas.

This Licensing Authority will expect applicants to offer their own measures to meet the licensing objectives however appropriate measures / licence conditions may cover issues such as:

- CCTV
- Supervision of entrances / machine areas
- Physical separation of areas
- Location of entry
- Notices / signage
- Specific opening hours
- Self-barring schemes
- Provision of information leaflets / helpline numbers for organisations such as GamCare.
 - Measures / training for staff on how to deal with suspected truant school children on the premises

This list is not mandatory, nor exhaustive, and is merely indicative of example measures.

11.2 This Licensing Authority will refer to the Commission's website to view any conditions that apply to Operator Licences covering the way in which the area containing the category C machines should be delineated. This Licensing Authority will also make itself aware of any

.....

mandatory or default conditions on these Premises Licences, when they have been published.

12. Casinos

12.1 Norwich city council recognises that current primary legislation (Statutory Instrument 2008 No. 1327) prevents the authority issuing a premises licence for a casino. However the following resolution has been made, should the legislation be altered to allow such a possibility.

There are currently no casinos operating within Norwich. Following debate at Licensing Committee on 30 January 2020 and further ratification at full Council on ?????? 2020 a resolution was passed not to issue casino licences within the City of Norwich as provided for in Section 166 Gambling Act 2005. This resolution may be reviewed as necessary, and at least every three years in line with the adoption of the Gambling Statement of Principles. There is no right of appeal against this resolution. Potential licence applicants should note that as a 'nocasino' resolution has been passed by this Council, no applications for casino premises licence will be considered. Any applications received will be returned with a notification that a 'no casino' resolution is in place.

13. Bingo premises

13.1 This Licensing Authority notes that the Commission's Guidance states

" 18.5 Licensing authorities need to satisfy themselves that bingo can be played in any bingo premises for which they issue a premises licence. An operator may choose to vary their licence to exclude a previously licensed area of that premises, and then apply for a new

> premises licence, or multiple new premises licences, with the aim of creating separate premises in that area. Essentially providing multiple licensed premises within a single building or site. Before issuing additional bingo premises licences, licensing authorities need to consider whether bingo can be played at each of those new premises."

- 13.2 This authority also notes that from 13 July 2011 a holder of a bingo premises licence may make available for use a number of category B gaming machines not exceeding 20% of the total number of gaming machines which are available for use on the premises. A licence variation must be applied for if operators wish to take advantage of the change to the legislation.
- 13.3 Children and young people are allowed into bingo premises; however they are not permitted to participate in the bingo and if category B or C machines are made available for use these must be separated from areas where children and young people are allowed. Social Responsibility (SR) code 3.2.5(3) states that 'licensees must ensure that their policies and procedures take account of the structure and layout of their gambling premises' in order to prevent underage gambling". In considering applications for bingo premises licences this authority will take account of these points.
- Bingo in clubs and alcohol licensed premises Bingo is a class of equal chance gaming permitted on alcohol-licensed premises, and in clubs and miners welfare institutes, under the allowances for exempt gaming in Part 12 of the Act. There are regulations setting controls on this form of gaming, to ensure that it remains low stakes and prizes activity. Where the level of bingo played in these premises reaches a certain threshold, it will no longer be authorised by these rules and a bingo operating licence will have to be obtained from the Commission for future bingo games. The aim of these provisions is to prevent bingo becoming a predominant commercial activity on such non-gambling premises.

> The threshold is that if bingo played during any seven-day period exceeds £2,000 (either money taken or prizes awarded), all further games of bingo played on those premises in the next 12 months will require an operating licence to be legal. The Commission has developed a statutory code of practice (The Code of Practice for gaming in clubs and premises with an alcohol licence) which is available on its website.

13.5 This Licensing Authority may consider measures to meet the licensing objectives such as:

- Proof of age schemes
- CCTV
- Supervision of entrances / machine areas
- Physical separation of areas
- Location of entry
- Notices / signage
- Specific opening hours
- Self-exclusion schemes
- Provision of information leaflets / helpline numbers for organisations such as GamCare.

This list is not mandatory, nor exhaustive, and is merely indicative of example measures.

14. Betting premises

14.1 The Act contains a single class of licence for betting premises although within this, there are different types of premises which require licensing.

> The Act also permits betting intermediaries to operate from premises. Section13 of the Act defines a betting intermediary as a person who provides a service designed to facilitate the making or acceptance of bets between others. Although betting intermediaries usually offer their services via remote communication, such as the internet, a betting intermediary can apply for a betting premises licence to offer intermediary services upon the premises, such as a premises based trading room.

14.2 Licensing authorities are responsible for issuing and monitoring premises licences for all betting premises. The issuing of premises licences is discussed in Part 7 of the Commission Guidance.

A betting operating licence authorises the holder to 'provide facilities for betting' and a betting premises licence authorises premises to be used for the 'provision of facilities for betting'. Thus, the primary gambling activity of the premises should be betting with gaming machines as an ancillary offer on the premises.

- 14.3 Gaming machines Section172(8) provides that the holder of a betting premises licence may make available for use up to four gaming machines of category B, C or D. Regulations state that category B machines at betting premises are restricted to sub-category B2, B3 and B4 machines. (Appendix 3 below summarises current machine entitlements)
- **14.4** Self Service Betting Terminals (SSBTs) Section 235(2)(c) provides that a machine is not a gaming machine if it is designed or adapted for use to bet on future real events. Some betting premises may make available machines that accept bets on live events, such as horse racing, as a substitute for placing a bet over the counter. These SSBTs are not gaming machines and therefore neither count towards the maximum permitted number of gaming machines, nor have to comply with any stake or prize limits. SSBTs merely automate the process that

can be conducted in person and the Act exempts them from regulation as a gaming machine.

However, where a machine is made available to take bets on virtual races (that is, results and / or images generated by computer to resemble races or other events) that machine is a gaming machine and counts towards the maximum permitted number of gaming machines, and must meet the relevant category limitations for the premises.

This Licensing Authority notes it is the Commission's view that the use of SSBTs is a form of remote communication and that a remote licence will be required if SSBTs are used to facilitate the making or accepting of bets by others.

This authority also notes that section 181 of the Act contains an express power for licensing authorities to restrict the number of SSBTs, their nature and the circumstances in which they are made available by attaching a licence condition to a betting premises licence (or to a casino premises licence where betting is permitted in the casino).

- 14.5 This Licensing Authority may consider measures to meet the licensing objectives such as:
 - Proof of age schemes

CCTV

- Supervision of entrances / machine areas
- Physical separation of areas
- Location of entry
- Notices / signage
- Specific opening hours
- Self-exclusion schemes

.....

 Provision of information leaflets / helpline numbers for organisations such as GamCare.

This list is not mandatory, nor exhaustive, and is merely indicative of example measures.

15. Tracks

- 15.1 This Licensing Authority is aware that tracks (as defined in section 353 of the Act) may be subject to one or more than one premises licence, provided each licence relates to a specified area of the track. In accordance with the Commission's Guidance, this Licensing Authority will especially consider the impact upon the third licensing objective (i.e. the protection of children and vulnerable persons from being harmed or exploited by gambling) and the need to ensure that entrances to each type of premises are distinct and that children are excluded from gambling areas where they are not permitted to enter.
- 15.2 This Licensing Authority will therefore expect the premises licence applicant to demonstrate suitable measures to ensure that children do not have access to adult only gaming facilities. It is noted that children and young persons will be permitted to enter track areas where facilities for betting are provided on days when dog-racing and/or horse racing takes place, but that they are still prevented from entering areas where gaming machines (other than category D machines) are provided.

This Licensing Authority may consider measures to meet the licensing objectives such as:

- Proof of age schemes
- CCTV
- Supervision of entrances / machine areas

.....

- Physical separation of areas
- Location of entry
- Notices / signage
- Specific opening hours
- Self-exclusion schemes
- Provision of information leaflets / helpline numbers for organisations such as GamCare

This list is not mandatory, nor exhaustive, and is merely indicative of example measures.

- 15.3 **Gaming machines** Where the applicant holds a pool betting operating licence and is going to use the entitlement to four gaming machines, the machines (other than category D machines) should be located in areas from which children are excluded
- 15.4 **Betting machines** This Licensing Authority will, in accordance with the Commission's Guidance, take into account the size of the premises, and the ability of staff to monitor the use of the machines by children and young persons (it is an offence for those under 18 to bet) or by vulnerable people, when considering the number/nature/circumstances of betting machines an operator wants to offer.

15.5 **Condition on rules being displayed** - The Commission has advised in its Guidance that:

"...Licensing Authorities should attach a condition to track premises licences requiring the track operator to ensure that the rules are prominently displayed in or near the betting areas, or that other measures are taken to ensure that they are made available to the public. For example, the rules could be printed in the race-card or made available in leaflet form from the track office."

15.5 **Applications and plans** - The Act (s51) requires applicants to submit plans of the premises with their application, in order to ensure that the licensing authority has the necessary information to make an informed judgement about whether the premises are fit for gambling. The plan will also be used for the licensing authority to plan future premises inspection activity.

Plans for tracks do not need to be in a particular scale, but should be drawn to scale and should be sufficiently detailed to include the information required by regulations. This authority appreciates that it is sometimes difficult to define the precise location of betting areas on tracks. The precise location of where betting facilities are provided is not required to be shown on track plans, both by virtue of the fact that betting is permitted anywhere on the premises and because of the difficulties associated with pinpointing exact locations for some types of track.

This Licensing authority will need to satisfy themselves that the plan submitted provides sufficient information to enable them to assess the application.

16. Travelling Fairs

Travelling fairs may provide an unlimited number of Category D gaming machines provided that facilities for gambling amount to no more than an ancillary amusement at the fair. They do not require a permit to provide these gaming machines but must comply with legal requirements about how the machine operates. Current stakes and prizes can be found in the Commission guidance.

Higher stake category B and C fruit machines, like those typically played in arcades and pubs, are not permitted. Fairground operators

> must source their machines from a Commission licensed supplier and employees working with gaming machines must be at least 18 years old.

> This Licensing Authority is responsible for deciding whether, where category D machines and / or equal chance prize gaming without a permit is to be made available for use at travelling fairs, the statutory requirement that the facilities for gambling amount to no more than an ancillary amusement at the fair is met.

- 16.2 This Licensing Authority will also consider whether the applicant falls within the statutory definition of a travelling fair.
- 16.3 It has been noted that the 27-day statutory maximum for the land being used as a fair, is per calendar year, and that it applies to the piece of land on which the fairs are held, regardless of whether it is the same or different travelling fairs occupying the land. This Licensing Authority will work with its neighbouring authorities to ensure that land which crosses our boundaries is monitored so that the statutory limits are not exceeded.

17. Provisional Statements

- 17.1 Section 204 of the Act provides for a person to make an application to the Licensing Authority for a provisional statement in respect of premises that he or she:
 - expects to be constructed;
 - expects to be altered; or
 - expects to acquire a right to occupy.
- 17.2 Once the premises are constructed, altered or acquired the holder of a provisional statement can apply to the Licensing Authority for the

.....

necessary Premises Licence. Section 205 of the Act sets out how the Authority should consider this application.

- 17.3 However, as stated at paragraph 9.6 the Authority recognises it is perfectly legitimate for an application to be made for a premises licence even though the premises are not finished. A Provisional Statement may be applied for if the applicant cannot provide adequate information for a full Licence application to be considered and determined.
- 17.4 In terms of representations about Premises Licence applications, following the grant of a provisional statement, no further representations from relevant authorities or interested parties can be taken into account unless they concern matters which could not have been addressed at the provisional statement stage, or they reflect a change in the applicant's circumstances. In addition, the authority may refuse the Premises Licence (or grant it on terms different to those attached to the provisional statement) only by reference to matters:
 - (a) which could not have been raised by objectors at the provisional licence stage; or
 - (b) which is in the authority's opinion reflect a change in the operator's circumstances.

17.5 The authority has noted the Commission's Guidance that "A licensing authority should not take into account irrelevant matters.... One example of an irrelevant matter would be the likelihood of the applicant obtaining planning permission or building regulations approval for the proposal."

18. Reviews

rall v

- 18.1 Requests for a review of a premises licence can be made by interested parties or responsible authorities. However, it is for the Licensing Authority to decide whether the review is to be carried out. This will be on the basis of whether the request for the review is relevant to the matters listed below, as well as consideration as to whether the request is frivolous, vexatious, will certainly not cause the Licensing Authority to consider whether to alter/revoke/suspend the licence, or whether it is substantially the same as previous representations or requests for review:
 - in accordance with any relevant code of practice issued by the Commission;
 - in accordance with any relevant guidance issued by the Commission;
 - reasonably consistent with the licensing objectives; and
 - in accordance with the authority's statement of licensing policy.
- 18.2 The licensing authority can also initiate a review of a licence on the basis of any reason which it thinks is appropriate.

.....

Part C: Permits/Temporary & Occasional Use Notice

19. Unlicensed Family Entertainment Centre (FEC) gaming machine permits

(Statement of Principles on Permits – Gambling Act 2005 Schedule 10 paragraph 7)

- 19.1 Where a premises does not hold a premises licence but wishes to provide gaming machines, it may apply to the licensing authority for this permit. It should be noted that the applicant must show that the premises will be wholly or mainly used for making gaming machines available for use (Section 238).
- 19.2 The Act states that a Licensing Authority may prepare a statement of principles that it proposes to consider in determining the suitability of an applicant for a permit and in preparing this statement, and/or considering applications, it need not (but may) have regard to the licensing objectives and shall have regard to any relevant guidance issued by the Commission. The Commission's Guidance also states:

"In its policy statement, a licensing authority may include a statement of principles that it proposes to apply when exercising its functions in considering applications for permits. In particular it may want to set out the matters that it will take into account in determining the suitability of the applicant. Given that the premises is likely to appeal particularly to children and young persons, licensing authorities may wish to give weight to matters relating to protection of children from being harmed or exploited by gambling and to ensure that staff supervision adequately reflects the level of risk to this group."

19.3 This authority notes that the Commission Guidance also states:

> "...An application for a permit may be granted only if the licensing authority is satisfied that the premises will be used as an unlicensed FEC, and if the chief officer of police has been consulted on the application....Licensing authorities might wish to consider asking applications to demonstrate:

- a full understanding of the maximum stakes and prizes of the gambling that is permissible in unlicensed FECs;
- that the applicant has no relevant convictions (those that are set out in Schedule 7 of the Act; and
- that staff are trained to have a full understanding of the maximum stakes and prizes."
- 19.4 It is noted that this licensing authority cannot attach conditions to this type of permit.
- Statement of Principles This Licensing Authority will expect the 19.5 applicant to show that there are policies and procedures in place to protect children from harm. Harm in this context is not limited to harm from gambling but includes wider child protection considerations. The efficiency of such policies and procedures will each be considered on their merits, however, they may include appropriate measures / training for staff as regards suspected truant school children on the premises, measures / training covering how staff would deal with unsupervised very young children being on the premises, or children causing perceived problems on / around the premises. This Licensing Authority will also expect, in accordance with the Commission Guidance, that applicants demonstrate a full understanding of the maximum stakes and prizes of the gambling that is permissible in unlicensed FECs; that the applicant has no relevant convictions (those that are set out in Schedule 7 of the Act); and that staff are trained to have a full understanding of the maximum stakes and prizes.

.....

19.6 This Licensing Authority will require the following to be submitted in addition to the application form and fee:

(1) Proof of the applicant's identity and age;

(2) Proof of the applicant's right to occupy the premises for which the permit is sought;

(3) (Where the applicant is an individual) a 'basic' Criminal Records disclosure dated no earlier than one calendar month on the day the application is received by the Licensing Authority. Holders of operating licences issued by the Commission are exempt from this requirement.

(4) An insurance certificate (or certified copy) confirming the availability of public liability insurance covering the proposed activity.

(5) A plan scale 1:100 of the premises showing:

 The boundary of the premises including any internal and external walls, entrances, exits, doorways and windows, and indicating the points of access available to the public.

b. The location of any fixed or temporary structures.

c. The location of any counters, booths, offices or other locations from which staff may monitor the activities of persons on the premises.

The location of any public toilets within the boundary of the premises.

The location of CCTV cameras.

- The location of any ATM or other cash/change machines.
- The proposed location of the Category 'D' machines.
- h. Details of non-category 'D' machines (e.g. skill with prizes machines).

g.

20. (Alcohol) Licensed Premises Gaming Machine Permits - (Gambling Act 2005 Schedule 13 paragraph 4(1))

- 20.1 There is provision in the Act for premises licensed to sell alcohol for consumption on the premises, to automatically have 2 gaming machines, of categories C and/or D. The premises merely need to notify the Licensing Authority. This licensing authority is aware it can remove the automatic authorisation in respect of any particular premises if it is satisfied that:
 - provision of the machines is not reasonably consistent with the pursuit of the licensing objectives;
 - gaming has taken place on the premises that breaches a condition of section 282 of the Act (i.e. that written notice has been provided to the licensing authority, that a fee has been provided and that any relevant code of practice issued by the Commission about the location and operation of the machine has been complied with);
 - the premises are mainly used for gaming; or
 - an offence under the Gambling Act has been committed on the premises.
- 20.2 If a premises wishes to have more than 2 machines, then it needs to apply for a permit and the licensing authority must consider that application based upon the licensing objectives, any guidance issued by the Commission under Section 25 of the Act, and "*such matters as they think relevant.*" This Licensing Authority considers that "such matters" will be decided on a case by case basis but generally there will be regard to the need to protect children and vulnerable persons from harmed or being exploited by gambling and will expect the applicant to satisfy the authority that there will be sufficient measures

.....

to ensure that under 18 year olds do not have access to the adult only gaming machines.

Measures which will satisfy the authority that there will be no access may include the adult machines being in sight of the bar, or in the sight of staff who will monitor that the machines are not being used by those under 18. Notices and signage may also be of help. As regards the protection of vulnerable persons, applicants may wish to consider the provision of information leaflets / helpline numbers for organisations such as GamCare.

- 20.3 It is recognised that some alcohol licensed premises may apply for a premises licence for their non-alcohol licensed areas. Any such application would most likely need to be applied for, and dealt with as an Adult Gaming Centre premises licence.
- 20.4 This licensing authority can decide to grant the application with a smaller number of machines and/or a different category of machines than that applied for. Conditions (other than these) cannot be attached to a permit.
- 20.5 It should also be noted that the holder of a permit must comply with any Code of Practice issued by the Commission about the location and operation of the machine.

21. Prize Gaming Permits - (Statement of Principles on Permits – Gambling Act 2005 Schedule 14 paragraph 8 (3))

21.1 The Act states that a licensing authority may "prepare a statement of principles that they propose to apply in exercising their functions under this Schedule" which "may, in particular, specify matters that the licensing authority propose to consider in determining the suitability of the applicant for a permit".

.....

- 21.2 This Licensing Authority has prepared a Statement of Principles which is that the applicant should set out the types of gaming that he or she is intending to offer and that the applicant should be able to demonstrate:
 - that they understand the limits to stakes and prizes that are set out in Regulations;
 - that the gaming offered is within the law.
 - clear policies that outline the steps to be taken to protect children from harm.
- 21.3 In making its decision on an application for this permit the Licensing Authority does <u>not</u> need to have regard to the licensing objectives but must have regard to any Commission Guidance
- 21.4 It should be noted that there are conditions in the Act by which the permit holder must comply, but that the Licensing Authority cannot attach conditions.

The conditions in the Act are:

- the limits on participation fees, as set out in regulations, must be complied with;
- all chances to participate in the gaming must be allocated on the premises on which the gaming is taking place and on one day; the game must be played and completed on the day the chances are allocated; and the result of the game must be made public in the premises on the day that it is played; the prize for which the game is played must not exceed the amount set out in regulations (if a money prize), or the prescribed value (if non-monetary prize); and
 participation in the gaming must not entitle the player to take part in any other gambling.

22. Club Gaming and Club Machines Permits

22.1 Members Clubs and Miners' welfare institutes (but not Commercial Clubs) may apply for a Club Gaming Permit or a Clubs Gaming machines permit. The Club Gaming Permit will enable the premises to provide gaming machines (3 machines of categories B, C or D), equal chance gaming and games of chance as set-out in regulations.

Members clubs and miner's welfare institutes – and also Commercial Clubs – may apply for a Club Machine Permit. A Club Gaming machine permit will enable the premises to provide gaming machines (3 machines of categories B, C or D). N.B. Commercial Clubs may not site category B3A gaming machines offering lottery games in their club.

22.2 This Licensing Authority notes that the Commission's Guidance states: *"25.44 The Local Authority has to satisfy itself that the club meets the requirements of the Act to obtain a club gaming permit."* In doing so it will take into account a number of matters as outlined in the Commission Guidance. These include the constitution of the club, the frequency of gaming and ensuring that there are more than 25 members.

The club must be conducted 'wholly or mainly' for purposes other than gaming, unless the gaming is permitted by separate regulations. The Secretary of State has made regulations and these cover bridge and whist clubs.

- 22.3 The Commission Guidance also notes that licensing authorities may only refuse an application on the grounds that:
 - (a) (i) for a club gaming permit the applicant is not a members' club or miners' welfare institute

(ii) for a club machine permit the applicant is not a members' club or miners' welfare institute or commercial club

- (b) the applicant's premises are used wholly or mainly by children and/or young persons;
- (c) an offence under the Act or a breach of a permit has been committed by the applicant while providing gaming facilities;
- (d) a permit held by the applicant has been cancelled in the previous ten years; or
- (e) an objection has been lodged by the Commission or the police.
- 22.4 There is also a 'fast-track' procedure available under the Act for premises which hold a Club Premises Certificate under the Licensing Act 2003. As the Commission's Guidance states: "Under the fast-track procedure there is no opportunity for objections to be made by the Commission or the police, and the grounds upon which an authority can refuse a permit are reduced." and "The grounds on which an application under the process may be refused are:
 - (a) that the club is established primarily for gaming, other than gaming prescribed under schedule 12;
 - (b) that in addition to the prescribed gaming, the applicant provides facilities for other gaming; or
 - (c) that a club gaming permit or club machine permit issued to the applicant in the last ten years has been cancelled."

22.5 There are statutory conditions on club gaming permits that no child uses a category B or C machine on the premises and that the holder complies with any relevant provision of a code of practice about the location and operation of gaming machines.

23. Temporary Use Notices

23.1 Temporary use notices (TUNs) allow the use of premises for gambling where there is no premises licence but where a gambling operator

.....

wishes to use the premises temporarily for providing facilities for gambling. Premises that might be suitable for a TUN, according to the Commission, would include hotels, conference centres and sporting venues.

The licensing authority can only grant a TUN to a person or company holding a relevant operating licence, i.e. a non-remote casino operating licence.

- 23.2 The Secretary of State has the power to determine what form of gambling can be authorised by TUN, and the relevant regulations The Gambling Act 2005 (Temporary Use Notices) Regulations 2007 state that temporary use notices can only be used to permit the provision of facilities or equal chance gaming, where the gaming is intended to produce a single winner, which in practice means poker tournaments.
- 23.3 There are a number of statutory limits as regards TUNs. Commission Guidance is noted that "the meaning of 'premises' in part 8 of the Act is discussed in Part 7 of this guidance. As with "premises", the definition of "a set of premises" will be a question of fact in the particular circumstances of each notice that is given. In the Act "premises" is defined as including "any place". In considering whether a place falls within the definition of "a set of premises", licensing authorities will need to look at, amongst other things, the ownership/occupation and control of the premises.

This licensing authority expects to object to notices where it appears that their effect would be to permit regular gambling in a place that could be described as one set of premises, as recommended in the Commission's Guidance. 24. Occasional Use Notices

24.1 Section 39 of the Act provides that where there is betting on a track on eight days or fewer in a calendar year, betting may be permitted by an occasional use notice (OUN) without the need for a full premises licence.

The Licensing Authority has very little discretion as regards these notices aside from ensuring that the statutory limit of 8 days in a calendar year is not exceeded. This Licensing Authority will though consider the definition of a 'track' and whether the applicant is permitted to avail him/herself of the notice.

25. Small Society Lotteries

- 25.1 Non-commercial gaming is permitted if it takes place at a noncommercial event, either as an incidental or principal activity at the event. Events are non-commercial if no part of the proceeds is for private profit or gain. The proceeds of such events may benefit one or more individuals if the activity is organised:
 - by, or on behalf of, a charity or for charitable purposes
 - to enable participation in, or support of, sporting, athletic or cultural activities.

Charities and community groups should contact the Licensing Authority for further advice.

- This Licensing Authority will register and administer smaller (noncommercial) society lotteries and applicants for lottery licences must apply to the Licensing Authority in the area where their principal office is located.
- 25.3 The society in question must be 'non-commercial' and the total value of tickets to be put on sale per single lottery must be £20,000 or less, or the aggregate value of tickets to be put on sale for all their lotteries

.....

in a calendar year must not exceed £250,000. If the operator plans to exceed either of these values then they may need to be licensed with the Commission to operate large lotteries instead.

- 25.4 For initial applications and where there is a change of promoter, this licensing authority reserves the right to require the promoter of the lottery to produce a 'basic' criminal records disclosure. For new applications, the licensing authority shall require the promoter of the lottery to produce a 'basic' Criminal Records disclosure dated no earlier than one calendar month on the day the application is received by the Authority.
- 25.5 This Licensing Authority may refuse an application for registration if in their opinion:
 - The applicant is not a non-commercial society;
 - A person who will or may be connected with the promotion of the lottery has been convicted of a relevant offence; or
 - Information provided in or with the application for registration is false or misleading,
- 25.6 Where this Licensing Authority intends to refuse registration by a Society, it will give the Society an opportunity to make representations and will inform the Society of the reasons why it is minded to refuse registration and supply evidence on which it has reached that preliminary conclusion. In any event, the Authority will make clear its procedures on how it handles representations.

25.7 This Licensing Authority may revoke the registered status of a lottery if it thinks that they would have had to, or would be entitled to; refuse an application for registration if it were being made at that time. However, no revocations will take place unless the Society has been given the opportunity to make representations. The Authority will inform the society of the reasons why it is minded to revoke the registration and will provide an outline of the evidence on which it has reached that preliminary conclusion.

.....

- 25.8 This Licensing Authority will adopt a risk based approach towards enforcement responsibilities for small society lotteries. This authority considers that the following list, although not exclusive, could affect the risk status of the operator:
- submission of late returns (returns must be submitted no later than id) three months after the date on which the lottery draw was held)

Part D - Exempt Gaming

- 26.1 Exempt gaming is equal chance gaming generally permissible in any club or alcohol-licensed premises. Gaming should be ancillary to the purposes of the premises. This provision is automatically available to all such premises, but is subject to statutory stakes and prize limits determined by the Secretary of State.
- 26.2 Equal chance gaming is gaming that does not involve staking against a bank and the chances of winning are equally favourable to all participants. It includes games such as backgammon, mah-jong, rummy, kalooki, dominoes, cribbage, bingo and poker.
- 26.3 The Secretary of State has set both daily and weekly prize limits for exempt gaming. Different, higher stakes and prizes are allowed for exempt gaming in clubs than in alcohol-licensed premises. Current limits are summarised in appendix 3 below.

Part E - Committee, Officer Delegation and Contacts

27 Committee decisions and scheme of delegation

- 27.1 This Licensing Authority is involved in a wide range of licensing decisions and functions and has established a Licensing Committee to administer them.
- 27.2 Licensing Sub-Committees made up of three Councillors from the main Licensing Committee will sit to hear applications where relevant representations have been received from interested parties and responsible authorities. Ward Councillors will not sit on a Sub-Committee involving an application within their ward.
- 27.3 Where a Councillor who is a member of the Licensing Committee is making or has made representations regarding a licence on behalf of an interested party, in the interests of good governance they will disqualify themselves from any involvement in the decision making process affecting the licence in question.
- 27.4 The Authority's authorised Licensing Officers will deal with all other licensing applications where either no relevant representations have been received, or where representations have been received and it is agreed by the parties that a hearing is not necessary.
- 27.5 Decisions as to whether representations are irrelevant, frivolous or vexatious will be made by the Authority's authorised Licensing Officers, who will make the decisions on whether representations or applications for licence reviews should be referred to the Licensing Committee or Sub-Committee. Where representations are rejected,

the person making that representation will be given written reason as to why that is the case. There is no right of appeal against a determination that representations are not admissible.

- 27.6 The table shown at Appendix 2 sets out the agreed delegation of decisions and functions to Licensing Committee, Sub-Committee and Officers. (It is derived from the details specified in section 154 of the Act and the Norwich City Council Constitution)
- 27.7 This form of delegation is without prejudice to Officers referring an application to a Sub-Committee or Full Committee if considered appropriate in the circumstances of any particular case.
- 27.8 In taking licensing decisions the Authority will be mindful of the public sector equality duty under the Equality Act 2010. Decisions will be taken with due regard to the need to:
 - Eliminate unlawful discrimination, harassment, victimisation and other conduct prohibited by or under the Equality Act 2010.
 - Advance equality of opportunity between people who share a protected characteristic and those who do not.
- Foster good relations between people who share a protected characteristic and those who do not.

1. Introduction

"Licensing statements, backed up by local area profiles, provide an opportunity for authorities to set out how gambling will be regulated in their areas, and their expectations of operators. They can be used to identify areas where the risk of harm from gambling may be greater due to the particular characteristics of an area, and how these risks can be mitigated".¹

Whilst there is no mandatory requirement to have a local area profile,² there are a number of benefits:

- it enables Norwich City Council as a licensing authority to better serve their local community, by reflecting the community and the risks within it
- the local area profile will help to inform operators of specific risks that will need to address in their risk assessment which will form a part of any new licence application, or an application to vary a licence
- it gives operators clarity as to the relevant factors and risks Norwich City Council takes into account when decision making
- it will lead to improved licence applications, with the operator already incorporating controls and measures to mitigate risk in their application
- it enables Norwich City Council to make robust but fair evidence based decisions
- it encourages a proactive approach to risk that is likely to result in reduced compliance and enforcement action.

There is increasing awareness about harmful gambling and its impact on families and local communities, as well as the individuals directly harmed by it. The following characteristics were identified in research sponsored by the Local Government Association (LGA)^{3 4} as indicating vulnerability to gambling related harm.

• Problem gamblers who are seeking treatment

- Youth
- Poor mental health
- Financial difficulties/debt
- Low IQ
- Unemployment
- Ethnic groups
- Homelessness.
- Immigrant population

This local area profile will use these categories to identify different parts of the local area where there are greater or specific risks of gambling related harm.

This document will reference data from a number of published sources which can assist local gambling operators prepare their local assessments.

This profile should be read in conjunction with the local area profile mapping tool available on the Norwich City Council website at (insert link to Licensing Mapping when signed off and is live) see Appendix 1 for a key to the metrics available on the map.

The profile is also intended to assist Norwich City Council and potential applicants when considering applications for sex establishments across the city. To that end it should be read in conjunction with the City Councils Policy on Sex Establishments.

2. Gambling participation and problem gambling

The Gambling Commission conducts an annual report⁵ into gambling participation. This survey measures behaviour, awareness and attitudes to gambling. The 2018 survey of 1,000 people aged 16+, used a nationally representative sample of the population of Great Britain.

The 2018 survey found that overall, gambling participation has remained stable compared to 2017 with 46% of respondents aged 16+ having participated in at least one form of gambling in the past four weeks (this compares with 45% in 2017). Over half of gamblers (52%) gamble at least once a week.

The National Lottery draws remain the most popular gambling activity, followed by scratch cards and other lotteries.

Excluding those who only bet on the National Lottery the age group 25-34 had the highest participation level in gambling at 40%.

Football and horse racing are the most popular betting activities and 18% of all respondents have gambled online in the past four weeks.




Figure 1. Past four weeks gambling participation by gender and age, the muted colours include National Lottery (NL) participation.⁵

Problem gambling is defined as behaviour related to gambling which causes harm to the gambler and those around them. This may include family, friends and others who know them or care for them.

The NatCen study Gambling Behaviour in Great Britain in 2016^6 which surveyed 14,000 people found that 0.7% of respondents identified as problem gamblers. Figure 2. shows that men (1.2%) are more likely than women (0.2%) to be problem gamblers. With the age group 25-34 being most at risk, again more men (2.4%) are at risk than women (0.2%).

b) People with substance and/or alcohol abuse or misuse problems

The Gambling Commission in its guidance to Local Authorities¹¹ identifies the following people as being vulnerable and needing protection

"people who gamble more than they want to, people who gamble beyond their means and people who may not be able to make informed or balanced decisions about gambling due to, for example, mental health, a learning disability or substance misuse relating to alcohol or drugs."

Locations listed below are places where people with substance abuse or misuse problems will be visiting to meet for support with problem gambling and hence 'pull' this potentially vulnerable group to this location. These places can also be located on local area profile mapping tool (insert link to Licensing Mapping when signed off and is live).

The list includes drug and alcohol treatment and recovery centres, clinics within GP surgeries, needle exchanges, and accommodation for persons who require treatment for substance misuse.

The major data source is FRANK¹² a key lever in delivering the government drug strategy, to reduce demand, by preventing people from taking drugs (including alcohol) in the first place. The following services are listed on the FRANK website for Norwich.

• City Reach, Under 1 Roof, Westwick Street, Norwich NR2 4SZ in **Mancroft** electoral ward.

City Reach provides healthcare services for people who find it difficult to visit mainstream GP services. The service is provided for people who are homeless, or those at risk of being homeless, sex workers, prisoners and ex-offenders, substance misusers, travellers and asylum seekers. Showers are available, as is advice on mental health or substance misuse, needle exchange and referrals to specialist services.

• Hebron House, 12 Stanley Avenue, Thorpe Hamlet, Norwich, NR7 0BE in **Thorpe** Hamlet electoral ward.

Hebron House is a safe, nurturing and intensively supportive community environment in which to rehabilitate from drug and alcohol dependency and the life-dominating problems that serious substance misuse can cause.

• The Matthew Project - Unity, Unit 8, 83-87 Pottergate, Norwich NR2 1DZ in **Mancroft** electoral ward.

The Unity service is a multi-agency team of drug and alcohol workers providing universal, targeted and specialist interventions for young people under 19 across Norfolk. The team also provide advice and support to parents and carers, young people whose family members use substances and professionals working with young people. Services include, harm reduction, needle exchange and access to residential substance misuse treatment.

• CGL Norfolk-Norwich, Adobe House, 5 Barton Way, Norwich NR1 1DL in **Thorpe Hamlet** electoral ward.

CGL, Norfolk Alcohol and Drug Behaviour Change Service is a free and confidential service for adults (including offenders), families, carers and affected others.

A further data source is Narcotics Anonymous¹³ this group use the therapeutic value of addicts working with each other to achieve recovery, they hold meetings in the following locations.

c) Youth

Children are singled out for additional regulatory protection in The Gambling Act 2005¹⁶ and the Geofutures¹⁷ research identifies the distinctive age range 10-24 of 'emerging adults' as well as younger children in 'transitional life stages' as vulnerable. Two metrics have been used to explore this category of risk, educational institutions and the population density of 10-24 years old.


Educational institutions



Population Demographic

Norwich has a youthful demographic in comparison to Norfolk and the rest of the country, with 24 per cent of residents in the 10 to 24 age group, as opposed to 16 per cent in Norfolk and 18 per cent in England.

Population density of 10 - 24 year olds is taken from Norfolk County Council, Norfolk Insights webpage¹⁹ data is based on Office of National Statistics (ONS) 2018 Mid-Year estimates.





This chart shows that the percentage of the age groups 15 -19 and 20 - 24 are higher in Norwich than in Norfolk and England. The table below highlights the particular electoral wards in Norwich where the % of 10 - 24 year olds is greater than the Norwich average and are at the highest risk of gambling related harm

d) Poor Mental Health

The NatCen Social Research on Gambling behaviour in Great Britain in 2016²⁰ found that problem gambling was more prevalent among those with the lowest well-being at 2.5% compared with only 0.5% for others and more prevalent at 2.2% among those with probable mental ill health compared with 0.2% for those with no evidence of probable mental ill health. This suggests that those with low well-being and probable mental ill health should be considered vulnerable to problem gambling.

There are several community mental health services in Norwich where service users are 'pulled' to.

The location of community NHS mental health services in Norwich

 The Wellbeing Service, Holland Court, The Close, Norwich, Norfolk, NR1 4DY in Thorpe Hamlet electoral ward

The Wellbeing Service offers help and support to improve wellbeing and manage stress, low mood and anxiety. Reducing the onset of mental ill health, preventing deterioration and promoting recovery by offering a range of flexible services

Youth-friendly (14 – 25 years) working in partnership with third sector agencies. A team of psychiatrists, psychologists, nurses, social workers, occupational therapists, assistant practitioners and community support workers.

The NHS Quality and Outcomes Framework (QOF)

The NHS Quality and Outcomes Framework (QOF)²¹ has a number of indicators across a range of key areas of clinical care and public health. The data used here is for the reporting year 1 April 2018 to 31 March 2019.

Because the metrics are recorded at GP surgery level they are useful proxies to determine the health of the population at electoral ward level. The two measures used are,

- Percentage of patients aged 18 or over with depression in the preceding year 1 April 2018 to 31 March 2019
- Percentage of patients with a recorded disease within the mental health and neurology group 1 April 2018 to 31 March 2019

e) Financial difficulties and debt

In the Geofutures (2015) study *Exploring area-based vulnerability to gambling-related harm: Who is vulnerable*?²² Found that low income – particularly individuals defined as being in poverty - may serve as a reasonable proxy for vulnerability.

To identify areas of Norwich where the population is experiencing financial difficulties and debt several data sources have been used. Financial hardship

Household Income

Norwich City Council use CACI Ltd Paycheck to provide consistent and reliable gross household income estimates at full postcode level across the UK. Income reflected by Paycheck is gross household income from all sources including earnings, benefits and investments.




Figure 8. CACI Paycheck²⁴ 2018 Household Income Norwich City Council map

The Indices of Deprivation 2019


The Indices of Deprivation are a unique measure of relative deprivation at a small local area level (Lower-layer Super Output Areas) across England. The Indices of Deprivation 2019 (IoD2019)²⁶ is the most recent release. The Indices provide a set of relative measures of deprivation for small local area level across England, based on seven different domains, or facets, of deprivation:

- Income Deprivation
- Employment Deprivation
- Education, Skills and Training Deprivation
- Health Deprivation and Disability
- Crime
- Barriers to Housing and Services
- Living Environment Deprivation

Combining information from the seven domains produces an overall relative measure of deprivation, the Index of Multiple Deprivation (IMD). In addition to the seven domain-level indices above, there are two supplementary indices: the Income Deprivation Affecting Children Index (IDACI) and the Income Deprivation Affecting Older People Index (IDAOPI). These are created as subsets from the Income Deprivation domain.

The **deciles** are calculated by ranking the 32,844 LSOAs in England from most deprived to least deprived and dividing them into 10 equal groups. LSOAs in decile 1 fall within the most deprived 10% of LSOAs nationally and LSOAs in decile 10 fall within the least deprived 10% of LSOAs nationally.

Overall 20.5% of the population of Norwich is in the most deprived decile nationally, and 5 wards are even higher than the percentage for Norwich Mancroft, Mile Cross, Wensum, Bowthorpe and Crome indicating high

Children under 16 living in low income families²⁷

The number of children living in families in receipt of Child Tax Credit whose reported income is less than 60% of the median income, or in receipt of either Income Support or Income-Based Jobseekers Allowance as a percentage of the number of children in families receiving Child Benefit. These statistics are based on a snapshot of several data sources on a specified day (usually 31st August), and measure the proportion of children in low income families.

f) Education, skills and training attainment

The Education, Skills and Training Domain of the IoD2019 measures the lack of attainment and skills in the local population. The indicators fall into two sub-domains: one relating to children and young people and one relating to adult skills. Lack of attainment can be used as a proxy for low IQ. Individuals with low IQ have been identified as being at greater risk of gambling related harm.²⁸

g) Unemployment

The British Gambling Prevalence Survey 2010²⁹ found 13.6% of people who were unemployed were categorised as *at-risk* gamblers compared with 7.5% of those in paid employment. A further 3.3% were *problem gamblers*, compared with 0.9% of those in paid employment. Those who are unemployed may be more vulnerable to experiencing difficulties with their gambling. High-time/high-spend and high-time only gamblers were more likely to live in areas of greatest deprivation, live in low income households and be unemployed. This group showed a relative preference for betting on horse races, fixed odds betting terminals and playing casino games.

The table below taken from the figures on Nomis Official Labour Market Profile³⁰, gives the 2019 claimant count (which is the number of people claiming benefit principally for the reason of being unemployed) and the percentage of people economically active (people who are either in employment or unemployed) and unemployed from the 2011 Census.

h) Homelessness

Rough sleeping³¹

Norwich City Council recorded 21 rough sleepers in autumn 2018 that is 3.3 per 10,000 population, the rate of homelessness for all of England is 2.0 per 10,000 population

Pathways³² is a partnership project to ensure rough sleepers and vulnerable people can access the help they need. Pathways operates from hubs across the city and through outreach work on the street. See Appendix 5 for details of the hubs and which electoral wards they are situated in, the local area profile mapping tool (insert link to Licensing Mapping when signed off and is live) identifies the types of services they provide for example food, advice, washing, shower.

Household homelessness³³

This is measured quarterly by household and district, ward level statistics are not available. January – March 2019 figures reveal that 307 households in Norwich were assessed as being owed a duty to be housed and there were 19 households in temporary accommodation 6 of which had children.

i) Ethnic groups

The NatCen social research study (2016) ³⁴ *Gambling behaviour in Great Britain in 2016,* combined data collected in 2012, 2015 and 2016, and concluded that problem gambling is associated with ethnicity. Across all three survey years, the proportion of problem gamblers tends to be higher among people from Black ethnic groups and among other minority groups (not covered by White, Black or Asian) than among those from Asian and White backgrounds.

The table of data below taken from Nomis³⁵ Census 2011 Ethnic Group data, highlights electoral ward hotspots where the % of population is higher than the Norwich average for the ethnic groups identified above .

The 2011 Census³⁹ recorded country of birth which can act as a proxy for immigrant populations in electoral wards.

I) Late Night Activity Zone

The city council has been working with the police and other organisations to help tackle any negative effects of the night-time economy on residents, businesses and visitors within the city centre.

As a result of this joint-working a number of measures have been put in place. They include the following:


- New access restrictions on residential side roads between 11pm and 6am daily (Cathedral Street, St Faiths Lane and Recorder Road) to reduce noise to local residents.
- Signage on residential roads reminding people to respect local residents at night.
- New CCTV cameras on Cathedral Street and Bank Plain/Queen Street.
- Improved policing of the night time economy areas (Prince of Wales Road area).

Along with this, and after consultation on the matter, the city council adopted a Cumulative Impact Policy (CIP) under the Licensing Act 2003 on 1 August 2015 around the Prince of Wales Road area.

The policy relates to premises applying for a licence, or a licence variation, to sell alcohol or late night refreshments between 9pm and 6am.

Since the introduction of the CIP, it has become the responsibility of any business applying for a new license, or looking to change an existing license within the designated area, to demonstrate that their business will not contribute to the anti-social behaviour before their application can be approved.

The City Council will expect similar considerations to be taken by applicants for gambling licences, permits and sex establishment licences in the defined area if they wish to trade during the late evening and night time period.



4. Summary

The Gambling Commission's introduction of local area risk profiles into practice and procedure represents a new opportunity for Norwich City Council and industry alike to think more deeply about the protection of vulnerable people from gambling-related harm. We would encourage all stakeholders to consider what this means and develop a more comprehensive understanding of who might be vulnerable and why.
















Appendix 2 Map of Norwich City Council electoral wards

1. Declarations of Interest

There were no declarations of interest.

2. Highways act 1980: application for licence to place tables and chairs on the highway - Gardeners Arms, 2-8 Timberhill, Norwich, NR1 3LB.

Phil Cutter, the landlord of the Gardeners Arms attended for this item.

The environmental protection, licensing and markets manager presented the report. The application was to place 10 tables and 30 chairs in an area adjacent to the Gardeners Arms on Timberhill, between the hours of 08:00 and 21:00 from March to October. The police had provided a representation detailing a number of suggested conditions to which the applicant agreed.

The applicant, Phil Cutter, landlord of the Gardeners Arms addressed the committee, he had been the landlord for 32 years and highlighted that the Gardeners Arms had an existing tables and chairs licence in place since September 1995. The area in the application was redeveloped by the city council 5 years ago but was underused, it was the location of street drinking and this precluded others from wanting to use the space. The intention was to use the area as an extension of the business's food operation. Local traders he had spoken with were positive about the application.

In response to member questions Mr Cutter said the application did not include umbrellas and that the impact of birds in the area would be monitored. The lectern in the plans would be used to mark an entrance point to the seating area; there would be two dedicated staff for the seating area which would allow one member of staff to bring out food. A bookings system would operate for tables. All food and drink would be served to those seated. The intention was to implement an electronic ordering system if the application was successful.

David Foskett, managing director of Moss and Leakey opticians, asked why no operational plan detailing how the area would work had been included with the application. He had no confidence the area would be adequately staffed. Mr Cutter said the intention was to serve substantial meals to those in the seating area. Mr Foskett asked how this would be managed, what if friends joined those seated, what stage were meals considered to be finished, would people stay and drink after their meals at the table.

Mr Foskett asserted that there were a number of issues with the operation of the current tables and chairs area that the business already operated.

(The meeting was suspended for ten minutes to allow the committee to take legal advice.)

The environmental protection, licensing and markets manager said that no complaints had been brought to his attention within the last four to five years in reference to the Gardeners Arms current tables and chairs licence. Before that period there had been complaints and these had been dealt with by offering advice to the licensee on the placement of barriers surrounding the area. The committee asked the police licensing officer if she was aware of any complaints in relation to the current licence. She confirmed that there were no complaints this year, there had been one complaint on the day of the Lord Mayor's celebration last year and the licensee had been offered advice in response to this complaint. There had been issues previously but nothing in the last couple of years.

Mr Cutter said in 2012/13 the current licence for tables and chairs was granted, he approached Mr Foskett and asked him if he experienced any issues to contact him directly. Mr Foskett said that they felt their complaints were not listened to and had admitted defeat.

(The committee adjourned for ten minutes to allow order to resume.)

In response to the committee's question Mr Cutter said people turning up at the licence area with a drink in hand wanting to sit down would be directed back to the pub or the current tables and chairs area directly outside the pub. When they finished their meal and were finishing a bottle of wine they would be allowed to remain at the table but not to buy further drinks. In terms of responding to people standing around outside the permitted area, they would be asked to move back up to the pub or the other tables and chairs area. Most people were very reasonable when asked to move on but if any problems they would call the police for assistance. Security staff were employed on the day of big events such as the world cup but the new application did not seek to have tables and chairs area they were asked to come back into the barriered licenced area.

Mr Foskett stated that the current licenced tables and chairs area was not well managed. They experienced lots of mess outside the business which they attributed to people drinking in the licenced area.

In response to members questions regarding managing those leaving the area to smoke, Mr Cutter said there was adequate seating in the area with three benches and two trees with brick surrounds. The application was for an area of seating on a slope and sturdy furniture would be used to combat any problems with this as it would be cut to sit on the slope adequately. Food would be served until 21:00 with the last food order taken at 19:00.

The police licensing officer said that this application represented a first for Norwich, it was accepted that it would need to be managed closely. The application came from a business operating successfully for number of years which had not received any recent complaints. Concerns relating to crime and disorder could be addressed in the conditions.

Mr Foskett said 16 years ago, he opened his business on Timberhill as a flagship store. Since the smoking ban, smokers had moved out on to the street causing problems with mess, damage to the front of the business, dirty glass, drinks on windowsills, broken glass and this had deterred people from walking along Timberhill. They considered nothing got done when they complained and therefore admitted defeated and stopped complaining.

Mr Foskett raised an earlier tables and chairs application for another business from 2008. The chair took advice from the legal advisor to the committee that it was not relevant to the application being heard in that it was a different application, relating to a different location and did not constitute a precedent for the committee to consider.

He asked Mr Foskett to summarise the points he wished to highlight from the application and these were agreed as:

- Erosion of highway space
- Highway obstruction
- Noise nuisance

Mr Foskett presented his concerns to the committee, he was surprised the application included no environmental report as there was a pigeon and rat problem in the area. He considered that the business and operation plan for the area should have been presented with the application to provide clarity. He was not certain how many staff would be in place and how tables and chairs would work on sloping ground. People would travel between the two tables and chairs areas with glasses in their hands and this would be intimidating and deter people from using Timberhill.

Mr Cutter acknowledged that this had never been done before and said there might be initial problems but these would be worked through with the police and licensing officers.

RESOLVED, unanimously to defer consideration of the application to 10 June 10:15 and ask the applicant to provide a more detailed operational plan to include:

- (1) The conditions suggested by Norfolk Constabulary;
- (2) Maintenance of the area and where the lectern would sit;
- (3) Reference to a guaranteed number of staff;
- (4) How the area would work in practical terms;
 - a) Including how parties with some eating and some not would be managed, what happened when customers tried to enter the area with drinks, and what happened once a meal had finished.

- b) Details of the furniture to be used and lectern, including how health and safety issues of being on a slope would be resolved;
- c) Details of finish time, set up and where the furniture would go when it was packed away

*3. EXCLUSION OF THE PUBLIC

RESOLVED to exclude the public from the meeting during consideration of items *4 to *7 below on the grounds contained in paragraphs 1 and 3 of Part 1 of Schedule 12(A) of the Local Government Act 1972, as amended.

*4. Suspension or revocation of Norwich City Council private hire drivers licence number No. 16/01887/HACKD - (Paragraphs 1 and 3)

The applicant attended with his legal representative and requested an adjournment of the item to a later date. The applicant's legal representative requested more time in order to conduct enquires on his client's behalf.

RESOLVED, unanimously, to adjourn the suspension or revocation of Norwich City Council private hire drivers licence number no. 16/01887/hackd to the next meeting of regulatory subcommittee.

*5. Application for renewal of a hackney carriage drivers licence – application ref: 19/00123 HACKD (Paragraphs 1 and 3)

The applicant attended and requested an adjournment of the item to a later date. The applicant requested more time in order to seek legal advice.

RESOLVED, unanimously, to adjourn application for renewal of a hackney carriage drivers licence – application ref: 19/00123 hackd to the next meeting of the regulatory subcommittee.

*6. Application for grant private hire drivers licence – application ref: 19/00241 PHDRIV (Paragraphs 1 and 3)

(The applicant and the environmental protection, licensing and markets manager were admitted to the meeting. The applicant produced his DVLA licence for inspection by the committee. A copy of the report was provided to the applicant at the meeting.)

The applicant explained the circumstances of the allegation against him and confirmed he had no outstanding charges or offences to answer to. He understood he was able to seek legal representation and have a representative attend with him.

(The applicant and the environmental protection, licensing and markets manager left the meeting at this point.)

The subcommittee considered the circumstances surrounding the allegation against the applicant, the committee had reviewed the evidence and did not speculate on information they did not have and considered the applicant passed the fit and proper person test. **RESOLVED**, unanimously, to grant private hire drivers licence – application ref: 19/00241 PHDRIV until August 2019.

The environmental protection, licensing and markets manager presented the report.

The applicant explained the circumstances of the convictions against him and confirmed he had no outstanding charges or offences to answer to. He understood he was able to seek legal representation and have a representative attend with him.

(The applicant and the environmental protection, licensing and markets manager left the meeting at this point.)

The subcommittee considered the circumstances surrounding the convictions against the applicant and considered the actions were now outside the current character of the applicant, and was a single occurrence over an eight year period which was unlikely to be repeated.

RESOLVED, unanimously, to grant private hire drivers licence – application ref: 18/01776 PHDRIV.

(The applicant and the environmental protection, licensing and markets manager were admitted to the meeting. The legal advisor informed the applicant of the subcommittee's decision and listed the reasons for this decision as minuted above. The legal advisor advised the applicant that he would receive written notification of the subcommittee's decision. The applicant and the environmental protection, licensing and markets manager then left the meeting.)

(The public were readmitted to the meeting at this point)

8. Town Police Clauses Act 1847/ Local Government (Miscellaneous Provisions) Act 1976: application to licence as a hackney carriage a Ford ProCab fitted with 8 passenger seats.

Natasha Morrison of A2B Taxis and Lucy Bradley of Cab Direct attended for this item

Members of the committee inspected the proposed hackney carriage.

The environmental protection, licensing and markets manager presented the report. In response to a member question he said there were no safety concerns with the seats in the vehicle.

Natasha Morrison explained that the business A2B taxis specialised in offering provision to individuals with disabilities. They purchased a Ford Procab as it was very disability friendly, older styles of hackney carriage allowed wheelchairs users to enter in reverse position along running boards and many users expressed anxiety about entering a taxi in this manner. The Procab offered a solid ramp which could be used to enter the taxi face forward by a wheelchair user.

The Procab also offered the ability to separate the front of the cab from the back of the cab, offering two seats in the front as well as the driver's seat. The company operated a number of contracts to taxi disabled children whom were accompanied by a carer or personal assistant to school. This ability to separate passengers enabled them to transport two children with assistants.

RESOLVED, unanimously, to grant a hackney carriage vehicle licence for a maximum of 8 passengers with the current 8 seat configuration and to take no enforcement action under the relevant byelaw as detailed in the report until the byelaws can be altered.

*3. Application for renewal of a private hire drivers licence: case numbers 19/01617/PHDRIV

(The applicant, the licensing assistant and the public protection team leader were admitted to the meeting. The applicant produced his DVLA licence for inspection by the committee. A copy of the report was provided to the applicant at the meeting.)

The applicant explained the circumstances of the endorsements against him and answered member's questions. He understood he was able to seek legal representation and have a representative attend with him. The applicant advised he had no pending matters outstanding.

The legal advisor noted that the report stated the applicant had failed to declare his convictions to the council but that he had no convictions which required declaring within the Green Book rules.

(The applicant, the licensing assistant and the public protection team leader left the meeting at this point.)

The subcommittee considered the circumstances surrounding the endorsements against the applicant. The committee reviewed the evidence and did not speculate on information they did not have.

*4. Application for renewal of a hackney carriage driver's licence – application ref: 19/01465/HACKD

(The applicant, the licensing assistant and the public protection team leader were admitted to the meeting. The applicant produced his DVLA licence for inspection by the committee. A copy of the report was provided to the applicant at the meeting.)

The applicant explained the circumstances of the convictions against him and answered member's questions. He understood he was able to seek legal representation and have a representative attend with him. The applicant advised he had no pending matters outstanding.

The chair asked the applicant why he had failed to disclose his convictions to the council as he was obliged to. The applicant stated that he had emailed and produced a screen shot print out of an email. The licensing assistant advised there was no record of an email being received.

It was noted that the applicant had been before committee on 10 June 2019 and members had reviewed the report and minutes of that meeting. It was noted that the caution relating to this incident was still shown on the applicant's full disclosure list. The applicant advised in June that the caution was not valid and would be removed. The applicant advised that he did not know that he was required to do anything in order to have the caution removed. The chair advised he recalled the discussion from June's committee and the applicant had advised that this would be actioned.

Regarding the applicant's convictions the legal adviser asked if he pleaded guilty at court and the applicant confirmed he had, the legal adviser asked if he accepted he had not notified the council of his convictions or his change of address within the required seven day period which the applicant accepted he had not.

(The applicant, the licensing assistant and the public protection team leader left the meeting at this point.)

The committee considered the applicant had not declared his two convictions to the council as required to by his licence. The committee considered the council's conviction policy and took account of the committee report and minutes from the June 2019 committee.

The subcommittee considered the circumstances surrounding the convictions against the applicant. The committee reviewed the evidence and did not speculate on information they did not have.

RESOLVED, unanimously, to refuse the renewal of Hackney Carriage driver's licence to the applicant (application reference 19/01465/HACKD) as the committee considered that the applicant did not satisfy the test of being a fit and proper person to hold such a licence under s51 LG(MP)Act 1976.

(The applicant, the licensing assistant and the public protection team leader were readmitted to the meeting. The chair informed the applicant of the subcommittee's decision. The legal adviser advised the applicant that he would receive written notification of the subcommittee's decision and of his right to appeal to the Magistrates' court within 21 days of receipt of the written notification. If the applicant chose not to appeal, he could apply again for a licence in the future).

(On being told of the decision the applicant shouted at members of the committee, he said his treatment by the committee was "double standards" and shouted "shame" repeatedly at members. The committee officer asked the applicant to leave and he left still shouting.)
