Background

- 1. On 12 April 2019 Dr Alessandro Zambelli from Brighton University contacted Cllr Maxwell as the chair of Mousehold Heath Conservators with regards to a research project investigating the 'past, present and future of English urban commons'.
- 2. Dr Zambelli explained that the research is looking into areas of open space which are or were commons and which have a close relationship to urban centres with their associated and unique pressures (and pleasures).
- 3. Dr Zambelli's reseach is based on the need for them to be understood and managed in particular and sensitive ways. The research is interested in how a deep understanding of the historical and archaeological past of 'urban commons' can help and inform the custodians, stakeholders and users of their present and their future.
- 4. 4 'commons' have been selected as case studies; Mousehold Heath being one of them, along with Newcastle Town Moor, Valley Gardens in Brighton which was once, but is no longer, officially a common and Clifton Down in Bristol
- 5. It has been pointed out to Dr Zambelli that Mousehold Heath is not a registered 'common'. Mousehold heath has been selected as the work is also looking is also interested in urban open spaces which were common land or even those which have common-like qualities.
- 6. A conference and workshop has been organised for 9 July in Brighton. As the custodians of Mousehold Heath a request has been received for representatives to attend the conference and workshop. There is a particular interest in hearing about the views and experiences of managing the heath and to hear how the 'exemplary management plan' was developed.

The attendance of the chair and vice-chair of the Mouseshold Heath Conservators acting as ambassadors for the heath, would provide a perspective from the 'custodians' of the heath to be expressed. The parks and open spaces manager would be able to share experience from a strategic and planning perspective and a Mousehold warden will be able to share operational experiences. All will present different perspectives and experiences.
- 9. Attendance at the conference will result in Mousehold Heath being discussed and more people becoming aware of the heath and the work of the conservators. It will also support a large piece of research work, recognising the value and importance of such spaces; and will have its profile raised through the publication of the research project findings.
- 10. The work will also be valuable professional development for the Mousehold warden and the Parks and open spaces manager.
- 11. Dr Zambelli has agreed the attendance of the four representatives would be benefical.
- 12. The research project will cover the costs of travel and accommodation. It will not cover meals outside of the conference programme and these would be paid in accordance with the council's subsistence rates.
