Purpose

Members are asked, in accordance with the delegation of licensing functions contained in the Norwich City Council Statement of Licensing Policy (Licensing Act 2003), to consider the application for the grant of a premises licence in respect of Erpingham House, 22 Tombland Norwich NR3 1RF following the receipt of relevant representation.

Recommendation:

It is recommended that members determine the application to grant the premises Life in accordance with the:

- Licensing Act 2003 and subsequent regulations
- Guidance issued under Section 182 of the Licensing Act 2003; and
- Norwich City Council Statement of Licensing Policy

Policy Framework

The council has five corporate priorities, which are:

- People live independently and well in a diverse and safe city.
- Norwich is a sustainable and healthy city.
- Norwich has the infrastructure and housing it needs to be a successful city.
- The city has an inclusive economy in which residents have equal opportunity to flourish.
- Norwich City Council is in good shape to serve the city.

This report meets the people live independently and well in a diverse and safe city and the city has an inclusive economy in which residents have equal opportunity to flourish corporate priorities.

Report Details The application

- 1. The applicant is Plantrepreneur Limited.
- 2. The proposed DPS is Louie Blake.
- 3. The application seeks to allow the licensable activities, times and opening hours as set out in the application form, which is attached at appendix A. This also includes the steps proposed to promote the licensing objectives (operating schedule).

Summary

- 5. In determining the application with a view to promoting the licensing objectives the sub-committee must give appropriate weight to:
 - a. the steps that are appropriate to promote the licensing objectives (i.e. the prevention of crime and disorder; public safety; the prevention of public nuisance; and the protection of children from harm);
 - b. the representations (including supporting information) presented by all the parties;
 - c. the guidance issued under Section 182 of the Licensing Act 2003 (national guidance); and
 - d. the council's own statement of licensing policy.
- 6. The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- a. Grant the application as asked;
- b. Modify the conditions of the licence by altering or omitting or adding to them;
- c. Reject the whole or part of the application;
- d. Refuse to accept the proposed DPS.
- 7. The sub-committee is asked to note that it may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.
- 8. The representations received appears to relate to issues that fall under the licensing objectives.



M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

- The Licensee, that is the person in whose name the premises licence is issued, shall ensure that all times when the premises are for any licensable activity, there are sufficient competent staff on duty at the premises for the purpose of fulfilling the terms and conditions of the licence and for preventing crime and disorder. The Licensee shall ensure that all staff will undertake training in their responsibilities in relation to the sale of alcohol, particularly with regard to drunkenness and underage persons. Records will be kept of training and refresher training.
- b) The prevention of crime and disorder

Any incidents of a criminal nature that may occur on the premises will be reported to the Police.

The Licensee will install comprehensive CCTV coverage at the premises and it is operated and maintained at the premises.

The CCTV system shall conform to the following points:

- 1. Cameras must be sited to observe the entrance and exit doors both inside and outside.
- 2. Cameras on the entrances must capture full frame shots of the heads and shoulders of all people entering the premises i.e. capable of identification.
 - 3. Cameras viewing till areas must capture frames not less than 50% of screen.
- Cameras overlooking floor areas should be wide angled to give an overview of the premises.
 - 5. Be capable of visually confirming the nature of the crime committed.
 - 6. Provide a linked record of the date, time and place of any image.
 - 7. Provide good quality images -colour during opening times.
 - 8. Operate under existing light levels within and outside the premises.
 - 9. Have the recording device located in a secure area or locked cabinet.
 - 10. Have a monitor to review images and recorded picture quality.
 - 11. Be regularly maintained to ensure continuous quality of image capture retention.
 - 12. Have signage displayed in the customer area to advise that CCTV is in operation.
 - 13. Digital images must be kept for 31 days.
 - 14. Police will have access to images at any reasonable time.
 - 15. The equipment must have a suitable export method, e. G. CID 24 24 of A 6 hat the police can make an evidential copy of the data they require. This data should be in the native file format, to ensure that no image quality is lost when making the copy, if this format is non-standard (i.e. manufacturer proprietary) then the manufacturer should supply the replay software to ensure that the video on the CD can be replayed by the police on a standard computer. Copies must be made available to Police on request.

Appropriate fire safety procedures are in place including fire extinguishers (foam, H20 and CO2), fire blanket, internally illuminated fire exit signs, numerous smoke detectors and emergency lighting (see enclosed plan for details of locations). All appliances are inspected annually.

All emergency exits shall be kept free from obstruction at all times.

d) The prevention of public nuisance

All customers will be asked to leave quietly.

Clear and legible notices will be prominently displayed to remind customers to leave quietly and have regard to our neighbours.

e) The protection of children from harm

The licensee and staff will ask persons who appear to be under the age of 25 for photographic ID such as proof of age cards, the Connexions Card and Citizen Card, photographic driving licence or passport, an official identity card issued by HM Forces or by an EU country, bearing the photograph and date of birth of bearer.

All staff will be trained for UNDERAGE SALES PREVENTION regularly.

A register of refused sales shall be kept and maintained on the premises.



 - Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
 - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed


500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.


Recorded Music: no licence permission is required for:

- any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
- o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
- o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
- Where taking place in a building or other structure please tick as appropriate (indoors may include a tent).
- For example the type of activity to be authorised, if not already stated, and give relevant further details, for example (but not exclusively) whether or not music will be amplified or unamplified.

- 12. An applicant's agent (for example solicitor) may sign the form on their behalf provided that they have actual authority to do so.

We do not wish to return to how it was five years ago.

To prevent public nuisance	On the grounds of noise leaking from the building if there is amplified or live music which will cause a nuisance to residents in the area. Erpingham House is not suitable for live music or amplified music as it was originally a Georgian era residential building and then offices, now a restaurant. It does not have sufficient soundproofing or airconditioning to be a nightclub or music venue. When previous occupants of the restaurant and adjacent similar buildings had live or amplified music, we were kept awake at night and frequently had to complain to the staff or to the council. There is no undertaking in the licensing application to keep the windows closed or to have noise limiters.

Hi,

I'd like to object to the extension of hours at Erpingham House until 2am, and the playing of live music until this time, on the following grounds:

Prevention of public nuisance

People leaving the venue at 2am will cause a noise nuisance in the surrounding area, which includes several residential areas amongst the shops and other businesses. The venue backs on to the Cathedral Close, where some elderly residents live, and is in close proximity to other areas which have experienced anti-social behavior due to the late night economy. Adding a further late venue on the edge of this area will increase footfall and is inappropriate.

Additionally, the late-night music has the potential to cause noise nuisance if not properly controlled. A level of live music noise that would be acceptable at 9pm as part of the normal running of a restaurant would cause a significantly higher impact on the wellbeing of nearby residents in the early hours of the morning. As the doors open and close to the venue, this noise will unavoidably creep out into the surrounding area. Residents here live a reasonable distance from the acknowledged late night economy area and late night music will be a nuisance they cannot get away from.

Further to this, any late-night moving of rubbish out of the venue at the end of the night will cause a potential noise nuisance, particularly glass bottles. Residents in other areas with late night venues complain of the significant noise of this, as well as the nuisance of the rubbish not always being stored correctly for disposal.

Prevention of crime and disorder

The extra volume of people in the area late at night, many of whom will have consumed alcohol, has high potential to increase crime and disorder in the area. Increasing the number of late licensed premises in an area is known to increase crime and disorder, and Erpingham House is close enough to the Prince of Wales Road area as well as the closer establishments on Queen Street for this to be a factor.
