Safer Norwich Partnership – Half Year Performance Update

Summary: As part of the committee's role in scrutinising the Safer Norwich Partnership this is the six monthly opportunity for members to gain an overview, and to ask is the Safer Norwich Partnership achieving its commitments?

Members are provided with a copy of the Delivery Boards paper - SNP performance to 31 March 09 - appendix 1, which gives a breakdown of performance for the year compared to the previous twelve month period. Also provided are the Safer Norwich Area Priorities for each of the areas covered for Norwich - appendix 2 and a list of the members of the Safer Norwich Partnership - appendix 3.

At the November 2008 meeting of scrutiny the Community Safety Manager explained that the National Indicators in the partnership plan are new and as yet not base-lined. This means that figures for comparison will not be available until March 2010. However, the exception to this is NI17 which is the measure of people's perception of anti-social behaviour in their area. The NI actually started as the respect indicator which means that the question had been asked twice before this year in March 2004 and in June 2006.

In **2003 – 04**, 38%, **2006 – 07**, 23% and **2008 – 09**, 19.9% felt that ASB is a problem. Please see the next page of this report for explanation as to how this question is asked.

Recommendation: For the scrutiny committee to ask – is the Safer Norwich Partnership achieving its commitments and if not to consider if more detailed scrutiny work is required.

1. **Annex A: British Crime Survey methodology for aggregating 7 strands of anti-social behaviour perception measure**

1.0 Safer Norwich Partnership performance

The LAA local indicator to reduce “all crime” includes a target for Norwich of an 8.25% reduction across all crimes (a total of 16414 offences overall) the crimes are broken down into categories so that action can be taken to resolve trends.

As can be seen from the above figures Norwich CDRP has met its overall in crime reduction target in most crime types. Three categories have underperformed, explanations given below.

Explanations

Violent Crime

Violent crime in Norwich is mainly linked to the night-time economy in the Prince of Wales road area. Although the trend is down we may not reach the target of 8.25% reduction this is why the chart shows up as amber. The drop in incidents over the past year is partially due to the implementation of a trial taxi marshalling service; funding for the Marshalling scheme is due to run out around Christmas time and is likely to be discontinued unless further funding is available. The Police have also identified a major shift in the pattern of activity where the busy days are now Thursday to Saturday. A working group is being formed between police, council, residents and users to address the issue.

Drugs offences

There has been an increase of reported drug related offences over the past year, whilst this is a concern it should be remembered that quite small numbers are reported and therefore a large percentage increase can be generated by one or two arrests. Therefore these figures should be taken as more an indication of police activity rather than an increase in drug availability at 'street level'. This availability is impossible to calculate with these figures and requires highly specialised research.

Other Fraud and Forgery

This category is above target and will probably get further away from the LAA requirement in the short to medium term. The present economic climate may deepen this trend especially around 'Shoplifting' and 'Theft from Person'. Although several initiatives have been run of late against professional gangs coming into the area the problem is likely to remain with us for the foreseeable future.
