MINUTES

MOUSEHOLD HEATH CONSERVATORS

2.00pm - 5.25pm 20 June 2014

Present: Councillors Bradford (in the chair following election), Ackroyd, Barker,

Brociek-Coulton, Jones, Little, Margaret Bush and Chris Southgate

Apologies: Councillors Gayton, Maxwell and Price and Matthew Davies

1. APPOINTMENT OF CHAIR

RESOLVED to appoint Councillor Bradford as chair for the ensuing civic year.

2. APPOINTMENT OF VICE CHAIR

RESOLVED to appoint Councillor Little as vice chair for the ensuing civic year.

3. MINUTES

RESOLVED to agree the accuracy of the minutes of the meeting held on 17 January 2014 subject to amending 'Beach Drive' to read "Beech Drive" in item 3 and item 6 to read ...'Lenny Stamp' and ...'Paul Holley'.

4. PROVISIONAL OUTTURN 2013/14

The Finance control officer presented the report. He suggested conservators disregard the 'forecast variance' column in Appendix A and apologised that its inclusion had been unhelpful.

In reply to a question from Councillor Little, he said that setting a level of reserves was a matter for the conservators. As a large part of the budget was controllable programmed works, a level of 5% was deemed appropriate. He said that, in an emergency, the council's budgets were available to support the conservators if members of the council considered it appropriate.

In reply to a question from Chris Southgate, the Head of local neighbourhoods said that the conservators had signed up to a higher level stewardship scheme for restoring heathland with funding allocated by the rural payments agency.

RESOLVED to note the provisional outturn for 2013/14.

5. BUDGET MONITORING STATEMENT APRIL-MAY 2014

The Finance control officer presented the report.

The Head of local neighbourhoods said that the budget monitoring ensured visibility of the work programme that drove the precept requirement. He suggested a more detailed update on programme works and projects at the half year stage.

In reply to a question from Chris Southgate, the head of local neighbourhoods said that the budget for the refurbishment and repair to the pavilion had been agreed by the conservators some time ago. It was anticipated that the final costs should be within the scope of the approved budget.

RESOLVED to -

- (1) note the current budget monitoring position;
- (2) record the Mousehold Heath Conservators' appreciation of the contribution by Mark Smith, the finance control officer, to the work of the conservators and to wish him well as he would be leaving the council in the near future.

6. RISK PLANNING

The Head of local neighbourhoods presented the report.

In reply to comments and questions, he said that the preparation of an asset register was in the work programme for the current year. It would be reviewed annually thereafter. The chair suggested that listing notable trees should be included and Margaret Bush said that the Mousehold Heath Defenders had records of specimen trees on the heath.

RESOLVED to approve the risk plan subject to –

- (1) the action column regarding 'tree disease' be amended by adding ...'and take any appropriate action following guidance from the trees officer';
- (2) amending the action column regarding 'work plans and projects not completed' to read ...'...programme of works not completed...'.

7. DRAFT ANNUAL REPORT

The Head of local neighbourhoods introduced the draft annual report which had been produced following early discussions with the management sub group. It was still a work in progress with formatting required and photo captions to be added. A list of current conservators also needed to be included.

Chris Southgate suggested a number of ways he believed the draft could be improved including adding more information on the challenges faced i.e. bikers using the heath; the need to manage heritage elements such as the chapel site and the low percentage of actual heathland. The need to work within the budget was also a challenge but the successful way that the conservators did this was also a 'good story'. He believed that all of the paragraphs relating to 'push the pedalways' should be removed as this was not a Mousehold Heath Conservators' project.

Councillor Brociek-Coulton said that the Mousehold Fayre should be included in the events section and there should be more information on volunteering, particularly Norwich in Bloom. Also Jill Webb was listed as an 'individual volunteer' but was actually a member of the Mousehold Heath Defenders.

Margaret Bush suggested the introduction should include reference to why the heath was given to the city and to amend the first paragraph to say it was given by the Dean and Chapter and not 'the church'.

Councillor Little said there should be a reference to the varieties of birds seen on the heath. Chris Southgate agreed and suggested that information on all wildlife be included. This again was a good news element that should be emphasised.

RESOLVED to ask the head of local neighbourhoods to –

- (1) update the draft report as minuted above;
- (2) circulate the revised draft to a sub group including the chair and Councillors Ackroyd and Brociek-Coulton for "sign off" in July;
- (3) inform all Mousehold Heath Conservators when the report had been finalised.

8. PUSH THE PEDALWAYS

The Design, conservation and landscape manager, presented the report.

Councillor Little said he welcomed the plans for the project and was pleased with the routes chosen. He considered that the environmental sensitivities regarding creating the route with 3 metre wide asphalt on Beech Drive was relatively minor compared to the advantage of improving access to the heath for disabled people and those with wheelchairs as well as cyclists.

Margaret Bush said that the Mousehold Heath Defenders were happy with opening up Dragoon Street but did not support the proposal relating to Beech Drive as there were other available options which they believed were better. They also considered it would be dangerous where this route joined Gurney Road. They were not happy at the proposal to adopt the route as this was in fact a 'disposal' of part of the heath and Norfolk County Council would then have complete control over what happened with the route, including allowing utilities underneath.

Chris Southgate agreed with the Mousehold Heath Defenders' views that the Beech Drive option was not an appropriate solution. He questioned why the 2.5 metre wide

route had been deemed to be enough before but now a 3 metre wide route was proposed. They believed that the lighting of Valley Drive was not necessary. He did not accept the rationale that the route would discourage anti-social behaviour. He agreed that the Cavalry Drive element was more rational.

The Design, conservation and landscape manager said that the highways experts view was that the planned Gurney Road crossing would be a safe option. The proposal to adopt the route was to ensure that it was maintained by Norfolk County Council's budgets and this had worked well in other places such as the Marriott's Way cycle route. The 3 metre width would allow for a delineation of the space for cyclists and pedestrians. His aim was for the proposed lighting to include sensors which would light as people approached and if achieved would be a national first.

Councillor Ackroyd said that her main concern was the proposal for lighting.

Councillor Barker said that he could see 'pro's and cons' of the scheme. He was concerned not to spoil the heath; he did not consider that it was significantly more dangerous for cyclists to use the longer route and was unsure how lorries could be stopped from using an enhanced Beech Drive.

The chair welcomed the proposed improvement to Gurney Road and preferred this as the only route.

Councillor Brociek-Coulton also agreed that Beech Drive should not be included and that Gurney Road should be the only route.

Councillor Little said that the gradient was much worse for cyclists on Gurney Road. Enhancing Beech Drive would be acceptable encroachment on the heath. The conservators should aim to encourage more people to access the heath by cycle rather than the car. Also, he again implored the conservators to consider people with disabilities and pushchairs.

Some conservators suggested that improvements could be made to Beech Drive without the need for asphalt.

The Design, conservation and landscape manager said that if the conservators rejected the Beech Drive option the project board would probably implement the Gurney Road option alone. However, that was a matter for the board. Fewer cyclists would be encouraged to use the route and the project would be less successful as a result. In reply to a question from the chair, he could not say that the proposed crossing of Gurney Road would definitely go ahead if the Beech Drive route was not chosen.

In response to questions, the Head of local neighbourhoods said that his team would work with the push the pedalways project to ensure any works undertaken on the heath were carried out to the conservators satisfaction.

RESOLVED to -

(1) endorse the decision of the push the pedalways executive board to create a good quality route for cycling and walking between Heartsease

and the city centre by implementing the following project elements that affect the legally designated areas of Mousehold Heath –

- (a) (voting unanimously) laying a 3 metre wide, sealed surface twoway cycle track with lighting on the alignment of Dragoon Street in the vicinity of the Ranger's House and clearing the adjacent sunken lane to make it useable by pedestrians, including a shallow cutting to create level access to Gurney Road and reinstating heathland habitat to the slopes of the new cutting, as shown in Appendix 1 of the report;
- (b) (voting unanimously) widening of the footpath on the west side of Gurney Road between the junctions with Britannia Road and Mousehold Avenue into the carriageway by 1.2 metre average and the verge by 1.0 metre average (no more than 1.6 metre) to create a 3.0 metre wide unsegregated cycle and pedestrian path as shown in Appendix 1;
- (c) (with 4 voting in favour, none against and 4 abstentions) to introduce lighting on Valley Drive as shown in Appendix 1, subject to sensors being used;
- (d) (with 5 voting in favour, 3 against and no abstentions) the adoption as highway of the areas of cycle/walking path and associated lighting on Dragoon Street, Gurney Road, and Valley Drive that are created or upgraded through push the pedalways, in order to maximise the resources available for future maintenance;
- (2) (with 7 voting in favour, 1 against and no abstentions) not to endorse the proposal to lay a 3 metre wide sealed surface path along Beech Drive without lighting to provide an unsegregated cycling and pedestrian track between Gurney Road and Valley Drive.

Report

1. Management works

- Overgrown paths leading from the Pitch and Putt Car Park has been cut back by members of Norwich Community Green Gym, allowing easy access to the site.
- Two large areas of fly-tipping along Gilman Road were moved by Mousehold wardens.
- A large hole that developed at the base of St. James Hill was made secure and reported to be a collapsed sewerage pipe. Anglian Water has been notified.
- The miss-placed memorial plaque from Geoffrey Goreham's bench has been returned and is safe in the warden's office.
- Earth Heritage Trail interest points have been maintained by a Mousehold warden and volunteers.
- The Cavalry Track has been maintained by a Mousehold warden by cutting back encroaching vegetation.
- Ten trees and branches near footpaths have been made safe by the Mousehold wardens, including a large windblown birch tree blocking the Long Valley, and a large windblown birch tree which fell across Gurney Road in high winds.
- The Mousehold wardens have been working closely with PCSO's and Police Officers to stop a motorcyclist riding on the heath and recent occurrences of campers.
- Contact is maintained with the council's area contract development officer to ensure all relevant contracts are working effectively and to standard. Where issues have arisen these have been resolved.
- Ecological surveys including plant, bumble bee, bird, butterfly, and dragonfly have been completed by members of the community and Mousehold wardens across the site.
- Two new plant surveys have been undertaken by members of the Mousehold Heath Defenders.

2. Volunteers

There has been a total of 1017 volunteer hours worked on the site in the last quarter. These have been completed by:

- The Conservation Volunteers (TCV)
- Norwich Community Green Gym
- The Mousehold Heath Defenders
- A City College Duke of Edinburgh Award Scheme group
- The Assist Trust
- A work placement student and
- Volunteers from the community.

These works have significantly contributed to the implementation of objectives set out in the Management Plan, along with increasing community involvement in the many projects being undertaken on the site.

3. Events

A range of events have been organised or hosted on the heath in the last period, these being:

- The Mousehold Heath Fair organised by the Mousehold Heath Defenders, attracted an estimated 500 members of the community to the Fountain Ground.
- Eid al Fitr prayers to mark the end of Ramadan on Fountain Ground.
- A school holiday Playdays event organised by Norwich City Council Events Team took place on the Fountain Ground in July.
- Five events from the guided walk programme have been completed increasing understanding and enjoyment of the site.
- An environmental education activities evening for Sprowston Beavers group were organised and led by Mousehold wardens.
- Additional guided walks for Norwich MIND and Norwich Family History Group have been led by Mousehold wardens.
- A number of Forest School and Wild4 environmental education activities have taken place.
- Two Norwich HEART Heritage walks have been organised for the heath in mid-September.
- A number of bee and plant surveys have been completed on St. James Hill by members of Mousehold Heath Defenders and a Mousehold warden.
- Two new plant surveys have been undertaken by members of the Mousehold Heath Defenders

4. Annual work programme

Conservators requested at their last meeting an update on the implementation of the annual work programme. This is attached as appendices to the report.

The report helps to achieve the corporate objective to achieve strong financial management and stability, together with the service plan priority to improve Budget Preparation, Balancing and Monitoring to provide members (and officers) with relevant accurate and timely financial information to assist them in formulating policy and allocating resources, and to enable the Head of Finance to exercise the additional statutory responsibilities contained in the Local Government Act 2003, i.e. to advise on the robustness of estimates and adequacy of reserves, and to monitor performance against budget.

Report

- 1. Conservators approved a budget and precept for financial year 2014/15 of £210,904 at their meeting of 17 January 2014.
- 2. The Conservators have requested that budget reports be brought to their meetings on a regular basis. Budget monitoring is undertaken at the end of each month and Appendix A details the financial position for Mousehold Heath as at the end of May 2014, and comparison of the expected out turn to the annual budget. Where appropriate, explanations for variances are given in paragraph 2 below.
- 3. The letters preceding the explanation below cross reference with the corresponding letter in the comments column of Appendix A.
 - A. Depreciation is budgeted for but does not impact on balances, since it is reversed out of the revenue accounts. Impairments and IAS 19 Pension charges are not budgeted for, but again do not impact on balances, since they is reversed out of the revenue accounts.
 - B. The salary forecast outturn shown is for a £3.3k overspend, based on actual spend to date.
 - C. Premises costs have come more in line with the budget and we expect this trend to continue throughout the financial year.
 - D. The expected income from football pitches is not yet being allocated directly to Mousehold, also the budgeted grant income has also not yet been received.
 - E. Support service costs and other recharges will be processed later in the year. The forecast outturn reflects an expectation that recharges will match budgets.
- 4. Overall the budget shows a forecast underspend of £24,035. Because budget moves during the course of the year, to reflect virements and changes in anticipated overheads, and because some budget items (e.g., depreciation) do not impact on the conservators' balances, this figure does not compare directly with the precept figure.
- 5. The impact of the precept and forecast 2014/15 budget monitoring position (adjusted to neutralise the impact of budget and accounting adjustments described above) on the Mousehold Heath balances are as follows:

Conservators asked that the wardens:

- approach the company and ask what mutual benefit might be achieved from visitors to the café using the car park and the company helping to maintain the facility
- put on hold the surface treatment for the time being but to ensure it is completed for the summer

In view of the above Davina Tanner was invited to this meeting

Britannia Café

The work of the enterprise was introduced and how low category prisoners contribute to the café and other work across the city. Davina informed the meeting that the café was doing better than expected and she realised that there was additional use of the car park opposite the café.

The usage of the car park was discussed and Davina said that she was aware of:

- the impact on the car park since opening
- users of the heath were also using the café
- · the café encouraged visitors to the heath and
- provided a place for refreshments for visitors
- a further review in six months to assess the impact further

Davina informed the meeting that since the café opened there has been positive feedback about visits to Mousehold Heath placed on Trip Advisor; she also acknowledged that there was an impact on the car park, and the additional vehicles had a significant effect on the surface. Davina indicated that she may be able to offer a small contribution towards additional resurface work in the future.

Working Groups

Working groups for Mousehold was included in the discussion, and it was agreed that:

- Groups would be available from April 2015, after new accommodation block was in use
- Davina would liaise directly with Nigel Hales and Will Stewart about a work programme for clients
- There would be a review after six months of the work groups

Tree Works on St James Hill

Management of the trees on St James Hill was mentioned which seem to block the view across the city. Will Stewart informed the meeting that there was a current programme which will include:

- Coppicing of the bordering trees and bushes
- Trimming of branches; and
- Removal of one tree by bark ringing

The meeting was closed by David Bradford all where thanked for attending and reminded of the following Itinerant meeting to discuss further the wear and tear on Britannia Road car park.

The use of the woodland hollow at the junction of Gurney Road and Mousehold lane as a soak away was agreed.

The Pavilion

NPS were asked to:

- request proposals from the leaseholder on the possible future maintenance of the toilet provision on the basis of previous suggestions
- ask that the leaseholder confirms if they wish to explore an increased outside eating area
- investigate if the current lease describes public usage of the external eating area:
- progress the lease and explore how it can be used to minimise size of lorries using the car park and access track

The wardens were also requested to remove one dead conifer tree on the edge of the car park, to open up sight line of the pavilion.

An area of recent HLS funded heathland restoration was visited. Heather seedlings could be seen in areas scrub cleared and humus stripped earlier in the year. Conservators were pleased with the progress of the heathland restoration and HLS agreement.

Woodland Management

Beech Drive – a discussion concluded that encroaching vegetation onto the drive could be cut back, possibly by prison work parties.

The natural thinning of a large beech tree had created a natural glade which was now an important habitat for woodland butterfly species.

Woodland Management Update – an update was given stating that work was still being undertaken in accordance with Management Plan, including tree inspection

and safety surveys, ride and glade creation/conservation and the removal of nonnative invasive species such as laurel and sycamore saplings.

Woodland Diseases - the only woodland disease presently affecting the heath is the Horse Chestnut leaf minor disease (first recorded 2002 in UK) which causes leaves on Horse Chestnut trees to colour and fall early. If the tree is in good health it should survive the disease.

Due to Mousehold Heath's acidic soils, Chalara Ash Dieback disease is not a major threat as only a few young ash trees grow on the site.
